New Features and Enhancements

6.4 Release 1

- New Mirror added to K-Manager Pro giving the ability to sync Kula Mainframe Project files between Mainframes and a Master record on a PC file system, or simply to upload files from a PC file system library to one or more mainframes.
- GUI now gives a warning to show if IP Mav modules require an update. Go to menu 8871 to update an IP Mav module.
- Improved performance for Panels connected through poor quality networks.
- DSKs can now be added to outputs fed through Format Fusion HDR conversions.
- New Shadow Mainframe feature added allowing one mainframe to be shadowed by up to four shadow mainframes.
- New AMPP Control mode on Panels and Mav Remote units to allow Mav modules to be connected as IP Mavs.

Bug Fixes

6.4 Release 1

• GUI IP address dialogue boxes could not accept QWERTY keyboard entry.

- Keyboard text entry only worked using the popup.
- SWP08 router xpt not showing correctly on Macro Edit page.
- GPO setup menu (8733) would not respect the source selected when using the popup.
- Destination names not showing on SWP08 router protocol.
- Menu 12 could show incorrect resources.
- Kula AV not saving audio monitoring settings.
- MSP failed to update clock settings.
- MSP Saving Timestamp incorrect.
