## **Release Notes**

The *GV* Convergent Release Notes guide includes lists of new features and enhancements, bugs fixed, as well as known issues and limitations associated with the latest version of the GV Convergent software.

## **Overview**

GV Convergent version 3.4.0 is a major release that adds new features to GV Convergent. This release also contains a new bug fix. See also Known Issues and Limitations, on page 74.

## **Before Upgrading GV Convergent**

Backup the GV Convergent configuration to your local PC before you perform a GV Convergent software upgrade so that you can return to the previous GV Convergent software version if necessary. Refer to the *GV Convergent User Guide* for how to do this. See Related Documentation, on page 87.

Certain installation requirements must be met before upgrading; see Installation and Network Requirements, on page 87.

## New Features, Enhancements, and Bugs Fixed in GV Convergent

The following is a list of GV Convergent features and enhancements. The most recent items are marked with a star ( $\star$ ) symbol.

#### **GV** Convergent Version 3.4.0

This release adds the following enhancement(s) and corrects the following issue(s).

**New Features and Enhancements** 

★ [Ref. #PEG-11325] Improved tallying for composite levels: Changes were made so composite levels satisfied by the configuration of sub-levels of a destination are now available and tallied.

For example: creating a 2110 destination with streams assigned in the V, A and ANC levels will now tally the V-ANC and SDI levels when all of their sub-levels are on the same source.

- The composite level buttons on NV panels will now be enabled when the composite level's sub-levels are satisfied by the destination's configuration.
- The composite levels of logical destinations will now be returned to NP0017 client when the composite level's sub-levels are satisfied by the destinations configuration. You can see this in the bulk routing panel of GV-Orbit-Configurator.
- Composite levels SDI, V-ANC, and SDI-Audio are now tallied with the source when their sub-levels are all on the same source.

This affects NDAC clients and NV panels.

★ [Ref. #PEG-11221] Sirius 800 series router control support: GV Convergent now includes a Sirius 800 series router device type which can be added to the topology for more detailed control, including support for multiple controllers and different types of I/O cards. Note that the router must first be configured manually before being added to GV Convergent.

#### **Bugs Fixed**

★ [Ref. #PEG-11719] Removed one of the buttons for showing long stream names in the Logical Device Table: There were two buttons accomplishing the same purpose on the toolbars for the Stream Browser and Device Table in the Logical Device Table UI. In rare occurrences, selecting the destinations tab before the sources were loaded could cause the name to toggle between short and long names, thereby freezing the UI.

The button on the device table side has been removed to prevent this from happening. The toggle is now done for both sections on the Stream Browser toolbar.

★ [Ref. #PEG-11772] **Exposing IP streams were being hidden after a reboot:** Exposing IP streams on devices like UCP for use in logical devices was being reverted back to hidden after a reboot of the controller. This issue has been fixed.

#### **GV** Convergent Version 3.3.1

This release adds the following enhancement(s) and corrects the following issue(s).

#### **Bugs Fixed**

- ★ [Ref. #UCCM-3457] **Invalid router panel configurations in GV Convergent v3.3.0:** The panel buttons go dark when the GV Convergent configuration already includes router panel configuration(s), and:
  - You create a new panel on the GV Convergent topology, and assign an existing behavior.
  - You assign a new behavior to an existing panel.

## **GV** Convergent Version 3.3.0

This release adds the following enhancement(s) and corrects the following issue(s).

#### **New Features and Enhancements**

• [Ref. #PEG-11731] **NMOS option to enable multiple audio flows with group hint tag:** Now there is an option under NMOS devices to enable multi-flow audio when the device publishes more than 1 audio sender or receiver with the same group hint tag. After upgrading to this version, currently existing devices have this option turned OFF. Adding an NMOS device to the topology will have this option turned ON.

Quick Config can be used to set this option to ON or OFF for multiple devices by selecting device groups and using the Quick Config tool, and then selecting the appropriate option in the menu.

• [Ref. #PEG-11723] **Back button for NV panels:** GV control systems added a new button called *Back* that allows the panel user to go back to a previously visited page. The *Back* button stacks all visited pages or layout pages and will always be highlighted until the panel user reaches the end of the stack.

The new *Back* button is available under the built-in behavior list and can be dragged from the list and dropped on a panel button.

The list of visited pages is persisted and survives restart, reboot and failover actions.

• [Ref. #PEG-11722] **Previous page and Next page buttons for NV panels:** GV control systems added new buttons for NV panels; *Previous page* and *Next page*, to help cycle through specific layout pages by using these new buttons.

These new buttons are available under the built-in behavior list and they can be dragged from the list and dropped on a panel button.

• [Ref. #PEG-11721] **Updated names for existing NV panel concepts:** GV control systems did update some NV panels concepts:

The concept of *Panel Definition* is now replaced by *Panel Model*, where a panel model is a reference to a specific panel hardware type (for example, NV9654, NV9680, and so on).

The concept of *Panel Behavior* is now called *Panel Layout*. A *Panel Layout* is a template/canvas related to specific panel model. Panel layouts can have one or more pages with multiple buttons/functions. Panel layouts can be triggered and used from

other panel instances if those are from the same panel model, using the *Load Layout* option.

These changes have been made to improve the user interface clarity and they do not change the internal logic of the feature.

- [Ref. #PEG-11713] **Updated northbound SW-P-08 protocol to support Workbench and Luna controllers:** Updated SW-P-08 implementation to support northbound Dual controller Status Response Messages which are required for Workbench and the Luna 2460 to control the GV Convergent.
- [Ref. #PEG-11644] **NMOS IS-05 v1.1 support:** GV control systems now supports natively the IS-05 v1.1 API when available. It will be used over v1.0 when both versions are available.
- [Ref. #PEG-11635] **JPEG-XS (2110-22) flow type support for GVOP devices:** The support of JPEG-XS (2110-22) flow type was added in GV control systems for GVOP devices where it is now recognized as a video flow type and properly set with the corresponding bandwidth.

Logical levels should be used in order to prevent routing between compressed and uncompressed flows.

• [Ref. #PEG-11626] JPEG-XS (2110-22) flow type support for NMOS devices: The support of JPEG-XS (2110-22) flow type was added in GV control systems for NMOS devices where it's now recognized as a video flow type and properly set.

Logical levels should be used in order to prevent routing between compressed and uncompressed flows.

• [Ref. #PEG-11587] **2022 flow type support for NMOS senders:** The support of 2022 flow type was added in GV control systems for NMOS senders where the flow type is now recognized as an *SDI* logical level and is properly set.

NMOS receivers will keep using the **Video** logical level and routing to those receivers from **SDI** sources is already covered by the pathfinding algorithm, so no manual configuration is needed.

For information, manual changes to sender/receiver logical levels are persisted and not in-sync anymore with the NMOS registry data.

• [Ref. #PEG-11484] **Re-index action in Alias Editor now requires text input:** In order to protect against click errors, a captcha-style dialog was added to the re-index button of the Alias Editor to confirm the action which can have a big impact on router tables.

The dialog asks the user to type the text "re-index" to confirm the action.

• [Ref. #PEG-11470] **GV Convergent system's northbound control via Sony LSM (NS-BUS router matrix protocol):** GV Convergent system's northbound interface added the ability to control crosspoints through Sony LSM (NS-BUS router matrix protocol).

With this integration, logical sources/destinations from GV control systems, including those created for NMOS devices, are now available northbound to be used by Sony panels and commands received through *NS-BUS router matrix protocol* are properly handled.

LSM does not allow the configuration of the TCP port to which it connects to on an NS-BUS router device and uses 9720 by default. Because of this limitation, only one area of GV control systems can be controlled. GV control systems allow control of the area with the lowest external ID through the NS-BUS protocol.

When adding a GV Convergent system as an NS-BUS Device in the LSM configuration, the selected Protocol must be TCP and the Device Port Number value must be 8079. Device IP Address1 field should be the Virtual IP address of the GV Convergent system. Device IP Address2 field must be empty.

• [Ref. #PEG-11463] **Support of Global Pages / Panel Layouts concepts in GV Control Systems:** GV control systems added the support of *Global Pages* for NV panels.

The concept of *Global Pages* is called *Panel Layouts* in GV control systems, where a panel layout is a template/canvas related to specific panel model, with a set of buttons, to be used across multiple workflows and panels.

Panel layouts can have one or more pages with a set of buttons/functions. Panel layouts can be triggered and used from other panel instances if those are from the same panel model, using the *Load Layout* option. A new section called *Layouts* was added to the resources home page of the *Panel Configurator*. This section will display only the available layouts that are using the same panel model that is actually open in the *Panel Configurator*. One or more panel layouts can be selected and added to the panel, at once.

Panel layout pages/buttons can be changed from the main panel and the changes will be dynamically reflected on all panels where those pages are used, which has the advantage of updating multiple panels from one place with a single configuration.

Once the *Load Layout* option is added on a specific panel, it's possible to choose the exit mode, in order to leave a specific panel layout and go back to a specific stage, using the same existing EXIT options: Never, Preset, Take.

On the panel (Hardware or Software versions), the *Load Layout* button will display the name of the layout and once clicked, the panel layout will be open showing all buttons and functions of that specific layout.

Panel layouts can trigger other panel layouts (nested layouts) and the panel user is able to leave one layout, through the exit mode, to send the panel user to the previously visited panel page. The panel user can navigate through multiple panel layouts and also different pages from those panel layouts. The Back button and/or the Previous and Next page buttons can be used to cycle through the panel layout pages or through different panel layouts.

[Ref. #PEG-11437] **Audio Live dual redundancy support:** GV control systems added the support of dual redundancy for Audio Live.

Audio Live dual redundancy is supported in GV control systems with Audio Live v1.5.3 firmware version. With this new Audio Live firmware, each Audio Live unit can be configured as Independent, Redundant - Primary or Redundant - Secondary.

Those configurations are available through the RollCall Unit Redundancy menu, for each unit.

For dual redundancy support, both Audio Live units must be configured in redundancy mode, one unit as Redundant - Primary and the other one as Redundant - Secondary. Both units must have similar configurations, such as Input and Output configurations

and it's important to have both units up-and-running while configuring the Audio Live cluster.

Also, Primary and Secondary input and output ports from both units must be connected to RED and BLUE network switches and the corresponding spigots/streams must be properly configured.

Those configuration requirements are needed for a proper dual redundancy support in GV control systems.

Once the Audio Live configuration has been done, both units will be synchronized in order to exchange flows data in order to handle dual redundancy.

Dual redundancy on Audio Live was designed to prevent signal loss or signal glitching in case of a hardware failure of one of the two units. In order to achieve this, the Audio Live cluster is using, on the sender side, the primary port from the Primary unit as the cluster primary output, whereas the secondary port of the secondary unit is used as the cluster secondary output.

The secondary output from the primary unit and the primary output from the secondary unit are not used by the GV control systems.

On the receiver side, input ports from both Primary and Secondary units are used and join the same flows; primary input from the primary unit and the primary input from the secondary unit, as well as the secondary input from the primary unit and the secondary input from the secondary unit.

Note that Cisco DCNM host policies are only created for the streams corresponding to the ports that are actually used by GV control systems.

Once the Audio Live cluster configuration is completed, the cluster will be discovered in GV control systems, as a GVOP discovered device. If there is any configuration issue between the two Audio Live units, causing the cluster to be in a bad state (not synchronizing properly), then the discovered entity will not be discovered under the GV Convergent system and if the device is already on the topology, the status will change to offline.

A new icon is used to distinguish between Audio Live units using v1.5.3 firmware and units using an older firmware, regardless of the redundancy mode (Independent or Redundant).

The name of the discovered cluster and its related spigots will be using the ones from the primary Audio Live unit.

Once the cluster is added to the topology, the cluster group device will be listing two nodes corresponding to the two Audio Live units. Each node will provide the Audio

Live unit properties (Unit name, hostname, Control IP address, GUID. and so on) and also the specific unit ports and spigots.

The cluster device group is listing the ports and the spigots from the used units; the primary port is the one from the primary unit where the secondary port is the one from the secondary unit.

The cluster Redundancy mode property will reflect the current cluster status (Independent or Redundant).

The control port status (Online / Offline / Reconnecting) for the cluster is available on the cluster device group and also through the System Status page where the status for both units is also available.

There are no changes when connecting the Audio Live cluster to the topology network switches using Quick Connect tool.

While routing using the Audio Live cluster inputs, GV control systems will configure the four Audio Live cluster inputs and only use the primary output from the primary unit and the secondary output of the secondary unit. Those used input and output ports are properly displayed through the Path Manager.

While replacing a failing unit, it's important to apply the same IP configuration to the new unit as was applied to the previous faulty unit, otherwise tally issues may occur.

Independent Audio Live units from existing topologies, using an older Audio Live firmware, cannot be used for dual redundancy. Those units must be deleted from the topology, upgraded to v1.5.3 firmware (or higher), configured in a cluster mode and then they will be discovered by GV control systems.

No changes will be noticed if an independent Audio Live unit, using v1.5.3 Audio Live firmware (or higher) is added to the topology, except the new icon and the new unit Redundancy Mode, shown as Independent.

• [Ref. #PEG-11434] **NMOS improvements for A/B routing:** GV control systems added a new mechanism while routing from single-sided sources (A or B) to dual-sided destinations (A and B).

This was causing issues especially if routing a single-sided source from B to a dual-sided NMOS destination, as the NMOS receiver was trying to join the B flow on its A side, which may result in an unsuccessful route.

In order to instruct those NMOS receivers to join single-sided sources on specific interfaces, GV control systems now specify the interface to be used as the primary object, using the *transport\_params* list property, as part of the IS-05 connection management bulk request.

No changes were made if routing a dual-sided source to a dual-sided destination; the *transport\_params* list property will remain empty, which is an indication to use all available interfaces.

• [Ref. #UCCM-3146] **Global settings configuration for the NMOS registry application:** Configuration changes to the global settings of the NMOS registry application can be requested through Grass Valley support and services team.

Parameters such as the *priority*, *PTP domain number* and more can be updated and the configuration will be persisted across upgrades. Note that the configuration file is not persisted if the NMOS registry application is deleted or re-installed.

Please contact Grass Valley Technical Assistance Center (TAC) to help you with these configuration changes.

#### **Bugs Fixed**

• [Ref. #PEG-11730] **Routing issues from northbound control systems:** In previous versions of GV control systems using NP0017, there was the possibility for northbound control systems to encounter a routing issue if a DCNM control port was offline, due to the fact that GV control systems were sending unsuccessful status to those northbound systems.

This issue is now fixed as this error status is not included anymore in GV control systems reply and only a warning is displayed in the logs.

- [Ref. #PEG-11715] Virtual IP cleared to 0.0.0.0 on automatic failover: In some circumstances, an automatic failover caused by hardware or software issues could result in the Virtual IP address to be cleared from the System Controller configuration. This issue has been resolved.
- [Ref. #PEG-11667] Audit Logs accumulate infinitely and were never cleaned up: Audit Logs from GV control systems will now maintain a history of up to 90 files, instead of always preserving them all.
- [Ref. #PEG-11657] **DCNM host policies may not be deleted if dynamically decreasing spigot streams/flows:** A fix was made for a known issue in GV control systems if spigot streams/flows were decreasing which could be the case if the spigot went from a configuration with a higher number of audio streams/flows to a configuration with less audio streams/flows. This issue is now fixed.
- [Ref. #PEG-11654] Labels set on ports and streams will now carry over to the logical devices properly: There was an issue where if an automatically created logical device label was manually changed and then the corresponding stream's label was also changed, resetting the logical device label was no longer following changes from the stream's name. This issue is now fixed.
- [Ref. #PEG-11642] Automatic cleanup of unused tally records in the control system database: Some tally-related records were unnecessarily maintained in the control system database. These will be automatically cleaned up when installing this version. This can make the upgrade process take 5 to 10 minutes longer than usual.
- [Ref. #PEG-11605] NMOS Driver status now updates faster when the devices becomes
  online or offline: There was an issue where the connection status in the System Status
  Page could take up to 2 minutes to change when an NMOS device became unreachable
  or back online. This was fixed and the update should happen within 5 to 10 seconds
  now.
- [Ref. #PEG-11591] Audio Live inputs used as sources no longer clear multicast address on the B side when used in a take: When using an Audio Live input spigot directly as a source in a take to a destination that is not the same Audio Live unit, the B-side multicast address joined on the Audio Live input spigot would be cleared to 0.0.0.0. This is now fixed, and the multicast address will no longer change.

• [Ref. #PEG-11182] New improvements to handle redundancy for NMOS devices: Pathfinding issues were happening if NMOS devices were publishing their resources with a mix of redundant and non-redundant senders/receivers.

For NMOS devices, the redundancy for the node interfaces is exposed through the *interface\_binding* property from the related NMOS senders and receivers.

This property is used by GV Convergent NMOS controllers, as part of the IS-04 API, to establish the redundancy between the available interfaces published by the NMOS node.

If **Sender A** from **Device X** is publishing its **interface\_binding** with 2 interfaces (**eth1** and **eth2**) and from the same **Device X** another **Sender B** is publishing its **interface\_binding** with only one interface (**eth1**), GV Convergent NMOS controllers will consider **eth1** as redundant based on **Sender A** and as non-redundant based on Sender B and in this case the result won't be deterministic and issues may happen while mapping those resources to the appropriate interfaces.

Prior to the improvement made in this release, the workaround was to set those NMOS senders/receivers to be **all** either redundant or non-redundant, as a source/destination is either redundant or not, but not a mix of both.

As part of this release and in order to accommodate these unique configurations, GV control systems added a new mechanism to handle redundancy at the streams level (NMOS senders/receivers) and no longer at the port/interface level. So, issues related to those configuration should not affect the NMOS IS-04 discovery in GV control systems anymore.

#### **GV** Convergent Version 3.2.0

This release adds the following enhancement(s) and corrects the following issue(s).

#### **New Features and Enhancements**

• [Ref. #PEG-11570] **Ability to use audio channels with SDI streams:** GV Convergent already provides the ability to use specific audio channels related to MADI and AES streams, using the Channel Browser from the Logical Device Table. Those are available to be used for the creation of logical sources/destinations, by assigning the desired audio channels to the appropriate A1 to A16 levels.

This workflow is now available for SDI streams as well, as a replacement for the previous workflow where the Shuffle option was required but only available for logical sources. This new workflow is available for both logical sources and destinations.

• [Ref. #PEG-11297] Automatic workflows to support multi audio flows in GV Control Systems: GV control systems already support the creation of logical sources/destinations using multiple audio flows/streams, although those workflows were 100% manual, where level duplication was required to create new level families before assigning each of the audio flows to those families.

With this new workflow, GV control systems added the ability to automatically create logical sources/destinations using multiple audio flows/streams.

With GVOP devices, logical sources/destinations are created using the audio channels from the spigot streams. Spigot configuration allows the use of 1, 2 or 4 audio streams where the audio channels count is accordingly adjusted. The 16 audio channels from the automatic logical sources/destinations is created using the multi audio

streams/flows. For example, in a 2 audio streams configuration, each stream will have 8 audio channels. For a 4 audio streams configuration, each of the 4 streams will have 4 audio channels.

For NMOS devices, until NMOS IS-08 specifications are supported by GV control systems to leverage the audio channel mapping details provided by NMOS senders/receivers, GV Convergent Control system relies on the NMOS senders/receivers Group Hint Tag property to determine the available audio streams/flows to be used in order to extract the appropriate audio channels used for the creation of the automatic logical sources/destinations. GV control systems still provide the ability to create custom logical sources/destinations using specific streams and specific audio channels.

Routing between IP sources and IP destinations, with different flow configurations requires an AudioLive in order to convert audio flows into compatible ones.

#### **Bugs Fixed**

• [Ref. #PEG-10622] NMOS devices that are removed from a system can now be properly deleted from the topology: Because of a device delete handling issue, deleting an NMOS from the topology would not properly delete all of the device elements if this device was not properly discovered from the registry.

This lead to a problem where a device being replaced or reprogrammed with different UUIDs could not be cleanly deletable from the topology configurator.

#### GV Convergent Version 3.1.0

This release adds the following enhancement(s) and corrects the following issue(s).

#### **New Features and Enhancements**

- [Ref. #PEG-11479] Device port capacity configuration via template: Grass Valley control systems added a new property, at the device level, called *Default Port Capacity* (*bps*) for Network Switch and IP Device. When this value is set, it's used as the default capacity for all of the device's ports, if no value is explicitly set on the port.
   If used with an IP device and set on a port within the device group properties (port prototype), then this value overrides the default value set on the device.
- [Ref. #PEG-11472] **New screen for analyzing Audio Live spigot usage:** A new screen is available in GV Convergent which displays spigot usage and overall capacity of tielines, to better analyze possible problems with running out of resources.

#### **Bugs Fixed**

• [Ref. #PEG-11581] **GPO Tally rules now properly launch on boot:** GPO rules based on Tally were not properly started when booting the server. A failover to the stand-by server was required for the rule to come into effect.

This has been addressed and Tally-based rules will now properly start on the active server when the server boots.

• [Ref. #PEG-11567] **Exposed SDI stream setting is no longer reset for IQ devices:** When exposing the SDI streams of IQMIX, IQUCP, or IQAMD cards without using automatic sources and destinations, the driver would reset the exposed stream setting back to "Hidden" when the card was rebooted, or when the topology was activated. The setting will now only change when automatic sources and destinations are toggled on or off.

#### **GV** Convergent Version 3.0.0

This release adds the following enhancement(s) and corrects the following issue(s).

**New Features and Enhancements**

• [Ref. #PEG-11476] **DCNM network switch interfaces bandwidth capacity configuration:** GV control systems added an improvement for the DCNM driver where the interface's bandwidth capacity for the Cisco network switches are automatically and dynamically updated based on the information provided by DCNM APIs. When the bandwidth capacity is not available, a default value will be used (10G) and you need to

Also, another improvement related to the Cisco network switches interfaces label was made to publish the spine/leaf switch label and not only the interface label (**RED\_Spine\_9508 Ethernet1/3/2** instead of **Ethernet1/3/2**).

- [Ref. #PEG-11455] **Support of NMOS IS-04 v1.3 in GV Control Systems:** GV control systems added the support for NMOS IS-04 v1.3. This support does not cover any support for NMOS IS-07.
- [Ref. #PEG-11440] **DCNM 11.5(1) support:** GV control systems added the support of DCNM v11.5(1). Older DCNM versions are still compatible with new GV control systems.
- [Ref. #PEG-11319] **Home page improvements for NV panels:** GV control systems added new improvements for NV panels to better handle the panel's Home page.

Before those improvements, the first page of the panel was by default called *Home* for information purposes only but no specific workflows were related to this page.

With these new improvements, the first page of the panel is simply called **Page 1** and automatically assigned as the default Home page.

With multiple pages created, a new option called **Home Page** was added to the panel toolbar menu in order to configure a specific panel page as the Home page. When the page is already assigned as the Home page, the assignment option is grayed-out and the page borders are highlighted in red.

Under the list of pages, from the **Tool** menu, the assigned Home page has an icon to quickly flag the Home page.

Also, a new built-in behavior called *Load Home Page* was added. This new button can be added to the panel and when it's pressed, the user is automatically redirected to the Home page. If the Home page is updated, the same button will be dynamically updated to redirect to the new Home page.

• [Ref. #PEG-11310] **Copy/Paste improvements for NV panels:** GV control systems added the following improvements in the *Panel Configurator* while using copy/paste:

Copy/cut/paste buttons from one page to another and from one panel to another is now possible using either the icons in the toolbar or through keyboard shortcuts

Multi-select using the shift key is now possible:

- By holding the shift key and selecting the first and the last button/cell, all buttons/cells in between are selected. The same workflow is possible in reverse order as well.
- If the first and the last selected buttons/cells are in different lines, the entirety of the lines will be selected in reading direction, between the two buttons/cells.

• [Ref. #PEG-11303] **Panel Lock support for NV panels:** A new built-in behavior called **Panel Lock** has been added for NV panels.

Once the button added to the panel, it can be used to lock the panel and disable the panel buttons. Pressing panel buttons when it's locked won't have any effect.

When the panel is locked, all panel buttons go dark, except the **Panel Lock** button that becomes red and display **Panel Unlock**.

In the lock state, all panel logical source/destination labels still get updated.

In the same lock state, if the **Panel Lock** button is deleted from the **Panel Configurator**, the panel will be unlocked and the **Panel Lock** button will be deleted from the panel itself.

• [Ref. #PEG-11287] **Default destination support for NV panels:** GV control systems added support of **Default Destination** for NV panels.

Using the **Panel Configurator**, you now have the ability to use a specific logical destination as the panel default destination. The assignment is done by using the **Default Destination (DD)** option from the toolbar menu, under the **Destinations** tab/list.

Once the default destination is assigned, always under the **Panel Configurator**, the **Default Destination (DD)** option will be highlighted for that logical destination and the **DD** icon will be added to the destination cell. The same option is used to unassign the default destination. Assigning a new logical destination as the default one will remove the assignment from the previous logical destination.

Also, a new property called **Default Destination** was added to the panel property editor (global) to display the label of the default destination once assigned. When there is no default destination, the field is empty.

It is not required to have the default destination added to the panel in order to start using it.

Also, a new built-in behavior called **Default Destination** was added to the existing list. Once the button is added to the panel, it will display the current status of the assigned default destination in order to quickly and dynamically monitor its status. When this new **Default Destination** button is selected, there is an option under its property editor to show the destination tally or to disable it. It's actually enabled by default. If a new default destination is assigned, the button will be dynamically updated.

#### **GV Convergent Version 2.9.1**

This release adds the following enhancement(s) and corrects the following issue(s).

**New Features and Enhancements** 

• [Ref. #PEG-11450] Fast routing when using virtual crosspoints: improvements were made to virtual crosspoints to increase the routing speed.

#### **Bugs Fixed**

• [Ref. #PEG-11436] **Pathfinding improvements:** There was a limitation where takes were failing from 2022-6 sources to single NMOS destinations when the receiver device is only connected to the Blue (redundant) network. This limitation was related to the pathfinding and is now fixed.

- [Ref. #PEG-11421] Improved IQAMD and Audio Live MADI routing performance: When an Audio Live device has all of the IP signals required, routing an audio source to an audio destination with MADI channel mapping, the pathfinding algorithm will now automatically re-use joins already present on the Audio Live and destination device so that the only commands needed are simple crosspoints within the audio live matrix. This greatly accelerates shuffling of audio when signals are available on the Audio Live.
- [Ref. #PEG-11315] When using complex breakaway and shuffling, tielines were sometimes not used correctly: Some complex shuffling and breakaway routing workflows using a mix of GV Node, IPG-4901 and IQMIX cards would sometimes not update or use tielines correctly. #### **GV Convergent Version 2.9.0**

This release adds the following enhancement(s) and corrects the following issue(s).

#### **New Features and Enhancements**

• [Ref. #PEG-11201] Lock/Protect support for various users in GV Convergent: Improvements were added to GV Convergent northbound interface to handle lock/protect operations for various users.

Prior to those improvements, all operations were performed as the "admin" user, as the user ID was not considered while processing those northbound commands. With these improvements, GV control systems added the ability to prevent users to unlock destinations previously locked by other users.

In GV control systems, under *User Management*, an extra field called "External ID" was added and an "Unsigned Integer" value can be used for this new field.

When a command is received from the northbound interface, the control system tries to match the ID received within the command with the external ID of an existing user, such that the command is carried out as by that user. If no user is found or no user ID is supported by the northbound protocol, the command is executed as the "admin" user, the same way it was done before those improvements, in order to prevent breaking existing systems.

NP0016 and NP0017 protocols provide the user ID for various operations. The user ID is defined as an unsigned integer value from 0 to 4294967295 but itNOT use values beyond 2147483647 to avoid any conversion or any special handling of users ID in GV control systems. If the recommendation cannot be applied, please contact Grass Valley support for further details on how to configure those values in GV control systems.

Other improvements were made in the control system audit logging where operation details are now displayed in the logs to indicate the user name and its external ID, the northbound interface (for example, NP0017), type of commands (Device-based, Portbased, etc.) and if the command was received from a panel.

• [Ref. #PEG-11364] **Pathfinding improvements to support different IP configurations with single (A or B) and dual (A and B) source/destination devices:** Improvements were added to GV control systems in order to handle new combinations of different IP configurations where the source/destination devices are connected to either A network, B network, or both A and B networks for redundancy. Those improvements apply to devices using both GVOP and NMOS drivers, in the case of single hop pathfinding, where the source and the destination devices are directly connected to the network switches with no processing in the middle.

Also, *Purple Networks* where routes are made using sources **from** a device connected only to the **A** network **to** destinations of a device that is connected only on the **B** network, and vice-versa, are not supported yet.

Prior to this effort, GV control systems were always using the streams on the A network (main), as part of the pathfinding algorithm, to start looking for the appropriate path. So, takes were failing if the source device was only connected to the B network.

As part of those new improvements, the following combinations are now supported:

- Single A source to Single A destination (this was already supported).
- Single A source to Dual A/B destination (Improvements were made to properly handle the destination tally).
- Single B source to Single B destination (now supported).
- Single B source to Dual A/B destination (Improvements were made to properly handle the destination tally).
- Dual A/B source to Single A destination.
- Dual A/B source to Single B destination.
- Dual A/B source to Dual A/B destination (this was already supported).

Those combinations are also supported if using sources with different flow types (2022-6, 2110-20, 2110-30, 2110-40) with all level takes or breakaway/shuffle operations.

- [Ref. #PEG-11417] **HTTP redirections support in GV control systems while fetching NMOS senders SDP file:** Improvements were made in GV control systems to properly handle HTTP redirections while fetching an NMOS senders SDP file.
- [Ref. #PEG-11422] **Pathfinding improvements while using AES-67 level:** When using a source or a destination that is assigned one of the AES-67 logical levels directly with no channels configured, routing using such a source or destination will join the audio directly from source to destination without utilizing the Audio Live.

#### **Bugs Fixed**

- [Ref. #PEG-10501] **Take fails if topology interconnections do not match the spigot configuration:** there was a limitation in GV control systems related to spigot configuration where either no path was found, no receiver configured, or no receiver cleared, if the source or destination spigot was configured in A or in B mode. This issue is fixed now and this no longer happens.
- [Ref. #PEG-11337] **NVision Panel control memory leak fixed:** an issue was resolved that was causing NVision hardware or software panels to slowly leak memory on the control system server side. After weeks of operation, this could cause the control system to run out of memory and trigger an automatic failover condition.

• [Ref. #PEG-11413] **Physical Connections Table in Topology Configurator now always shows ports correctly:** there have been some instances where the Physical Connections Table UI in the Topology Configurator would no longer be able to display available ports for IP connections. This issue has been fixed.

#### **GV Convergent Version 2.8.0**

This release adds the following enhancement(s) and corrects the following issue(s).

**New Features and Enhancements** 

• [Ref. #PEG-11338] **GV Convergent northbound GVG Native Protocol implementation improvement:** The control system northbound GVG Native Protocol implementation no longer returns empty names if there is a gap in the logical sources or destinations' external IDs.

Based on the amount and length of names configured in the control system, in some cases a source or destination name could be missing in the returned response to a command.

- [Ref. #PEG-11333] **GV Convergent northbound GVG Native Protocol subscriptions support:** Support for the subscribe *SB* and unsubscrive *UB* commands of the northbound GVG Native Protocol has been added. The only supported subscription type is *DS* (subscription for destination status change by name). This allows a GVG NP client to subscribe to asynchronous crosspoint changes of all or specific destinations. Asynchronous notifications are sent in the form of an *NY* command from the control system to the GVG NP client. Please refer to the *Grass Valley Protocols Manual, Section 3, Series 7000 Native Protocol* documentation for further details.
- [Ref. #PEG-11332] **GV Convergent response pacing configuration for the northbound GVG Native Protocol BK command:** A new parameter has been added to the northbound GVG Native Protocol *BK* command. The new *m* parameter can be followed by no value or a value ranging from 0 to 999 and allows a GVG NP client to configure the control system response pacing to its needs. Providing a value of 0 to 999 delays response messages by that amount of time in milliseconds. No value means use the system default, which is currently 150 milliseconds. Please refer to the Valley Protocols Manual, Section 3, Series 7000 Native Protocolfurther details.
- [Ref. #PEG-11232] **Ability to display 24 characters for streams in the Stream Browser and in the Multilevel Table:** GV Convergent added the ability to display 24 characters for streams, in the *Stream Browser* and in the *Multilevel Table*. The IP/SDI icon was removed in order to gain more space.

Unlike the *Stream Browser* cells, the ones from *Multilevel Table* are adjustable by resizing the column, and can be adjusted to display more characters.

 [Ref. #PEG-11226] Ability to display streams full or short name in the Logical Device Table (Stream Browser and Multilevel Table): A new option was added to the Logical Device Table, in GV Convergent, to show either the full or short name/label, for both Streams and Devices.

The *constant of the Stream Browser* and the *Multilevel Table* as well, to toggle between full and short name/label. When the new button/option is

selected/unselected, both Stream and Device labels are updated to either show short or long name/label.

Also, when filtering by stream or device name/label, the filter will be applied on the labels that are currently displayed; either long or short labels. If a filter is applied and the button is selected/unselected, the filter will be re-applied based on the new values displayed.

[Ref. #PEG-11224] Ability to show streams full and short name in the Stream Browser info button/option: The button/option from the Stream Browser, in GV Convergent, now shows the streams full name as well as the streams short name.

#### **Bugs Fixed**

- [Ref. #PEG-11397] **Logical Device creation is now possible for K-Frame streams:** A K-Frame driver issue was preventing manual creation of logical devices in the Logical Device Table. This issue has been resolved.
- [Ref. #PEG-11356] **NV hardware panels can sometimes connect to the stand-by server:** An issue causing hardware NV panels to sometimes connect to the stand-by server and not obtaining its configuration has been resolved. Only the active server will be capable of receiving connections from these panels.
- [Ref. #UCCM-1647] **Routing issues using IQUCP with version 15.5.97 firmware:** Routing issues in the control system may occur while using an IQUCP with version15.5.97 firmware. When upgrading from an IQUCP card version with 4 spigot streams to the version 15.5.97 (with 3 spigot streams).

This issue is resolved now and there is no need to reset the card configuration or to reboot the card.

#### **GV Convergent Version 2.7.0**

This release adds the following enhancement(s) and corrects the following issue(s).

**New Features and Enhancements** 

• [Ref. #PEG-11323] **Support of NV9680 virtual/software panel:** GV Convergent added the support for the new NV9680 panel (hardware and software), which has 4 rows of 20 relegendable buttons, with 2 RU.

As part of this integration, a new layout for Panel Configurator was added.

- [Ref. #PEG-11300] **Ability to generate audio logical devices with selectable amount of channels per device:** GV Convergent added the ability to specify the desired number of audio channels while creating audio logical sources/destinations, from AES-67 streams, from the *Channel Browser*.
- [Ref. #PEG-11220] Video/Audio/Metadata IP flow bandwidth report in GV Convergent for GVOP devices: GV Convergent now dynamically reports the video, audio and metadata IP flow bandwidth of transmitters and receivers, for devices using GVOP, based on the flow presence and the standard reported by the cards.

• [Ref. #PEG-11166] **Support of NV8500 hybrid router connected to a gateway:** Improvements were made to support a mix of (de)embedder and SDI cards in the NV8500 hybrid router by selecting ports which are connected or not to a (de)embedder. For example, path finding will use a disembedder if an audio breakaway is requested and will use a SDI port if a SDI take is requested. This was conditioned on the fact that the hybrid router is connected to another SDI router or to source/destination devices.

Now, this is also supported if the hybrid router is connected to a gateway which sends/receives in TR-04 or 2110 format.

• [Ref. #PEG-11119] Automatic detection of the router type and cards in slots for NV8500 hybrid routers: The control system added the ability to detect automatically the router type once the router control ports are properly set.

Once the router type is detected, the internal wiring is built and the input/output slots are automatically and properly configured, including the slots number as well as the slots card type and the description.

No manual configuration is required anymore by the operator.

In case of card type change, the control system provides the ability to update the new card via an option on the control port called **Update Slotted cards**, that way the internal wiring is rebuilt to take into account the new updates for all slots cards. The update could be triggered from either the main or redundant control port and the user will be prompted to confirm the update.

#### **Bugs Fixed**

- [Ref. #PEG-11313] **Take to a destination may affect another destination not part of the take:** A bug fix was done for an issue where takes to a specific destination may affect other destinations not part of the take.
- [Ref. #PEG-11291] Virtual IP now fails over properly when the operating system runs out of memory: In the event of the GV Convergent serverout of memory on an active server, the failover that follows now properly re-assigns the virtual IP to the new server instead of leaving it on the faulty server.
- [Ref. #PEG-11229] NMOS Senders/Receivers with no interface\_bindings (empty) won't be mapped anymore to existing ports/interfaces: In the early NMOS days, GV control systems were mapping NMOS senders/receivers with no *interface\_bindings* (*empty*), to the existing ports/interfaces. This was done to accommodate some NMOS devices that were not properly reporting the *interface\_bindings*.

This accommodation no longer makes sense and was removed from GV control systems. Now, any NMOS senders/receivers that are missing *interface\_bindings* won't be listed under the existing ports/interfaces.

• [Ref. #PEG-10959] Latest Mac OS-X version support with NV Virtual Router Panels: The latest Mac OS-X version is now supported with NV Virtual Router Panels. Note that the Gatekeeper must be disabled for NV virtual panels to run on MAC OS.

#### **Bugs Fixed**

• [Ref. #PEG-11291] Virtual IP now fails over properly when the operating system runs out of memory: In the event of the GV Convergent serverout of memory on an active server, the failover that follows now properly re-assigns the virtual IP to the new server instead of leaving it on the faulty server.

#### **GV Convergent Version 2.6.0**

This release adds the following enhancement(s) and corrects the following issue(s).

#### **New Features and Enhancements**

• [Ref. #PEG-11225] **Quick Connect now remembers last selection of IP/SDI network choices:** In the Topology Configurator, the Quick Connect option will now remember the IP connection, SDI device generation, and the choice of main and backup network settings.

Note that this is saved on a per user basis in Windows. It is not system-wide to GV Convergent.

• [Ref. #PEG-11190] **DCNM v11.4(1) support:** The control system now supports Cisco DCNM v11.4(1).

#### **Bugs Fixed**

• [Ref. #PEG-11236] **Panel not coming online after upgrading to GV Convergent version 2.5.0:** If an NVision panel was in a state where a category was being displayed before an upgrade to GV Convergent version 2.5.0 was done, the panel would not come online after the update. It would be unaffected by the update if the current panel page had no categories displayed. This issue has been fixed in GV Convergent version 2.6.0.

#### **GV Convergent Version 2.5.0**

This release adds the following enhancement(s) and corrects the following issue(s).

#### **New Features and Enhancements**

• [Ref. #PEG-10915] K-Frame switcher with 25G connections support in the control system: K-Frame switcher 25G connections support was added to the control system.

• [Ref. #PEG-11103] **NV Hybrid routers support:** The NV Hybrid routers support has been added to GV Convergent.

A new virtual device called "NV Hybrid Router" was added to the list of virtual devices.

Once added to the topology, the router type can be selected from the available list: NV8140, NV8144, NV8280, NV8576 or NV8576. Plus the relevant control ports.

Once selected, the number of slots and ports are automatically adjusted based on the router type.

Then, the card type should be manually selected, for each input slot (Disembedder, MADI, SDI, No card) as well as for each output slot (Embedder, MADI, SDI, No card), as the automatic detection is not supported yet but planned for a later release.

Based on the card type, the ports are automatically enabled/disabled based on the expected card type configuration.

For output slots, the Disembedder/Embedder card type, that is used for shuffling on the SDI input, is also not supported yet and planned for a later release.

Also, MADI sources or destinations need to be directly connected to the same hybrid router.

The user has the ability to push the Lock/Protect from the Control System to the router for destinations that are directly connected to the router. This requires enabling the "**In router Lock/Protect enabled**" property on the control port.

Also, the router Lock/Protect status is displayed only for destinations directly connected to the router.

If a specific router port is locked/protected but not linked to any destination within the Control System, the Lock/Protect status wonfact they are not releasable.

Destinations Lock/Protect is performed via the panel and if a destination is locked by another user, any take to this same destination will fail.

A panel admin user has the ability to release locks made by another user where nonadmin users could only release locks they made.

• [Ref. #PEG-11160] **Panel Exit mode for categories:** A new property named *Exit Page* for the Category button can now be used to indicate which page the panel should navigate to upon selection of a category item. The default return page of the Category button will still be applicable If the *Exit Page* property is not set or if the *Exit Mode* is set to never.

**Bugs Fixed** 

- [Ref. #PEG-10769] **Unable to do more than one level breakaway to an IQUCP destination:** There was an issue where you were not able to do more than one level breakaway to an IQUCP destination. This issue is now fixed.
- [Ref. #PEG-10872] **K-Frame production switcher now able to fetch labels from GV Convergent:** In previous versions of GV Convergent, the K-Frame production switcher was unable to properly fetch source and destination labels from GV Convergent using the GVG NP protocol. This was because the labels that were returned were too many that were sent too quickly.

This has now been correctly paced down and the K-Frame can now receive labels properly.

• [Ref. #PEG-11146] **GV Convergent Device Names reverting to defaults after a cluster failover:** There was an issue where GV Convergent Device Names were reverting to defaults names after a cluster failover. This issue is now fixed.

#### **GV Convergent Version 2.4.0**

This release adds the following enhancement(s) and corrects the following issue(s).

#### **New Features and Enhancements**

- [Ref. #UCCM-1421] **DCNM v11.3(1) support:** The control system now supports Cisco DCNM v11.3(1) and is backward compatible with DCNM v11.2(1).
- [Ref. #PEG-11104] Categories that hold only one type of logical device now has a more specific icon: When a category holds only sources, its icon now shows an embedded source graphic.

When a category holds only destinations, its icon now shows an embedded destination graphic.

The icon will change dynamically as sources and destinations are removed or added to a category. If a category is empty or contains both sources and destinations, the current icon with no extra graphic is displayed.

The new graphics are available in the Category Configurator and Panel Configurator.

The main use for this is to have two categories in the same name, one with sources only and the other with destinations only and still be able to differentiate between the two within the GUI.

- [Ref. #PEG-11100] Sender/Receiver ports for NMOS devices with no streams attached are disabled by the control system: The control system creates sender and receiver ports for NMOS devices based on the node interface property. If no senders/receivers are publishing the same interface in their *interface\_bindings* property, the port is disabled by the control system.
- [Ref. #PEG-11042] **The property editor shows physical ports that are disabled:** The control system added the ability to display, in the property editor, physical input/output ports that are disabled.

Disabled streams and gateways (for IPG devices) remain hidden in the property editor.

• [Ref. #PEG-11108] **Category items now display in the order in which they are sorted:** In the Category Configurator, items can be manually set in a specific order which is appropriate for a specific workflow.

Prior to this version, when calling up a Category on a panel, the items of the Category would always be displayed in alphabetical order. Starting with this release, the order in which these items are displayed will now follow the same order in which they are displayed in the Category Configurator.

Category panel button assignments now have a new property called "Sort Mode" which can change this behavior to sort alphabetically again if required. Three options are available: "Manual" which is the default and uses the order from the Category or "A-Z" or "Z-A" for alphabetical sort ascending or descending.

The Category setting copy functionality was also enhanced so that a single setting can be applied to multiple Category button, this can be used to set the Sort Mode across multiple button assignments in bulk for a single panel behavior.

#### **Bugs Fixed**

• [Ref. #UCCM-1356] Audio logical levels set on IQAMD or Audio Live are no longer reset when reconnecting: If an AES-67 level on a stream is manually changed with an equivalent AES-67 level with a different amount of audio channels, the new level will no longer be overwritten when the control system reconnects to the device.

For example, if a stream with level AES-67-64 ch is manually changed to AES-67-16 ch on an a Audio Live stream, the new level (16 ch) will stay the same regardless of the actual channel count on the device.

• [Ref. #PEG-11074] **Device control port's status may stay at** *Unknown* **if the topology has a DCNM control port:** An issue was encountered when the topology has network switches with DCNM control port. Other control ports could be affected and could stay at *Unknown* status if you deactivate and re-activate the topology within a few seconds. The issue does not happen if there is no DCNM control port.

The workaround was to Deactivate the topology, wait until the DCNM control port goes offline and then activate the topology.

This issue is now fixed and no workaround is needed.

• [Ref. #PEG-10846] **Receiver streams multicast IP address are set to 0.0.0.0 if the control system is not able to get the information:** In previous versions of the control system, when a new generic IP device was created with ports and their related streams, the multicast IP address of the sender and receiver streams were set using a specific pattern (224.x.x.x).

Setting the multicast IP address, for receiver streams, using default values, could lead you to think that the receiver is actually joining a sender with the specified default multicast IP address. This was noticed especially with NMOS receivers where the *sender\_id* is set to null.

In the new control system version, those **receiver** multicast IP addresses are set to 0.0.0.0 if the control system is not able to get them through the driver. This is applicable only for receiver streams.

• [Ref. #PEG-10791] **IPVU receivers video format automatically updated by the control system:** The control system now supports the control of the IPVU (joining streams) and also support the control of the IPVU parameters.

#### **GV** Convergent Version 2.3.0

This release adds the following enhancement(s) and corrects the following issue(s).

#### **New Features and Enhancements**

- [Ref. #PEG-11008] **Support of disconnecting NMOS flows via an IS-05 command:** The IS-05 connection management request sent by the control system will set the *master\_enable* flag to false if the source IP address is 0.0.0.0.
- [Ref. #PEG-11007] **Display the status of NMOS devices that are not available for control via IS-05:** A new property has been added to NMOS control ports called *IS-05 Controllable*. • [Ref. #PEG-10946] **Exposed streams setting management in the Stream Configurator:** Allow the user, using the Stream Configurator, to filter displayed streams by *exposed stream* property and also the ability to expose or unexpose streams via selection.

This is useful when the user would like to expose only certain streams in a system (for instance, only the Audio streams of a specific device).

- [Ref. #PEG-10906] **GV Convergent System Status Page now displays Densité Manager memory usage:** In the GV Convergent application, the System Status Page now displays the memory usage of the local Densité Manager. The percentage reflects the memory used out of its allocated heap size of 8GB.
- [Ref. #PEG-10899] **New option for wide widgets in Router Control UI:** The Router Control UI has a new option for making the source and destination double their width to accommodate longer labels.

The option is available independently for sources and destinations and is persisted for the currently logged in user, meaning that re-launching the Router Control UI or GV Convergent will remember the previously set value.

Note that this preference is also saved on a per user basis in Windows, meaning the setting has to be set on every PC and user where the GV Convergent runs.

• [Ref. #PEG-10806] NDAC NP0017: Lock and Protect destinations support: The control system now provides support for *Lock* and *Protect* destinations.

The user has the ability to lock/unlock and protect destinations via the *Router Control* using the *Lock, Release* and *Protect* available options.

The control system stores the locks in its database and they are preserved after a restart/reboot. Destinations will remain locked/protected.

In practice, the control system does not read a lock from a router and does not control it.

If a configured panel in the control system is used, a user must be assigned and that prevents other users from removing the protect. An admin user can override other users.

In the NP0017 protocol, Lock/Protect commands require a user ID. Currently, the control system northbound implementation does not take into account the user ID and simply considers all commands executed as the admin user. Lock for various users is not supported yet.

Lock and protect currently affects all levels of the destination and does not consider individual levels. Locking one level locks all destination levels and the control system does not yet support specific lock levels.

• [Ref. #PEG-10733] Warn user when GV Convergent version and the connected server version do not match: A warning is displayed to the user if the GV Convergent version is different from the version of the connected server. If both versions are matching, no warning will be displayed.

A confirmation is prompted. If the user selects *OK*, the client will continue to load as per normal. If *Cancel* is selected, the application will go back to the login screen.

• [Ref. #PEG-10588] **Unique custom level names on a panel:** On a panel, we are limited to 8 characters for a Tally: 3 lines of 8 characters.

In the Logical Level Editor, a short name must have 8 characters or less. A custom level is built (by duplicating the factory ones) with the first 3 letters of the resulting short label and ".." and the last 3 letters from the resulting short label.

The resulting short label is the concatenation of the a prefix given by the user, the short label of the copied logical level and a suffix given by the user (prefix and suffix can be empty).

For example,

if the Short Label Prefix is **Test** and the Factory level is **AES67-64**, the short name will be **Tes..-64** 

if the Short Label Suffix is **Test** and the Factory level is **AES67-64**, the short name will be **AES..est** 

- [Ref. #PEG-10342] **DNS-SD Support for the NMOS registry discovery:** GV Convergent can now automatically discover an NMOS registry via DNS-SD given the DNS server and search domain. The DNS server and search domain are automatically retrieved via the OS (if available), but can be overridden by the user in the Area Configurator. If the DNS information is changed in the OS, GV Convergent must be restarted to retrieve the new values from the OS. As before, the user still has the option to set a static NMOS registry URL if desired.
- [Ref. #PEG-10150] Control port added to a device by importing a spreadsheet: The feature Spread Sheet Import/Export now supports ControlPorts in a specific sheet.

#### **Bugs Fixed**

- [Ref. #PEG-11010] Random issue with GV Convergent failover mechanism: An issue related to the failover mechanism was noticed where you could end-up with an active server or loss of the topology. This issue is fixed.
- [Ref. #PEG-10945] Unable to reuse a discovered device if it was deleted from a device group instead of deleting the entire device group: If there are multiple discovered devices in a single device group, and any individual device is deleted from the group, the discovered device does not become available in the discovered device library to be dropped on the topology again. This issue is now fixed.
- [Ref. #PEG-10927] **IS-05 bulk stage requests to NMOS receivers dontransport\_params anymore:** IS-05 sent by the control system won*transport\_params* anymore, as allowed by NMOS specs to accommodate receivers that don*transport\_params* with an empty list.

• [Ref. #PEG-10922] **GV Convergent database migration issue if upgraded from an old GV Convergent version to 2.1.2:** The issue was encountered while upgrading from an old GV Convergent version to GV Convergent version 2.1.2. The issue affects the migration module.

Workaround: The fix is to upgrade to a more recent version.

- [Ref. #PEG-10890] DCNM control port can be disabled on an active topology: We added a feature to allow the user to disable/enable the DCNM driver on an active topology. This feature is a tool to help support teams to solve potential configuration issues on a live system without impacting the routing functionality or other control port devices. Some other useful troubleshooting data is also added to system snapshots.
- [Ref. #PEG-10855] Routing requests done in parallel can lead to GV Convergent not being able to process routes anymore: Prior to GV Convergent 2.1.3, if multiple routing requests were made (like issuing routes via Northbound API while a large Salvo is executing), it is possible the system could stop processing routes until a failover or restart of GV Convergent was done.

• [Ref. #PEG-10344] Cannot select some MADI streams in the Logical Device Table: The issue where we were not able to select / drag some streams of the Stream Browser of the Logical Device Table in a logical source level column, is now fixed.

- [Ref. #PEG-10855] Routing requests done in parallel can lead to GV Convergent not being able to process routes anymore: Prior to GV Convergent version 2.2.0, if multiple routing requests were made (like issuing routes via Northbound API while a large Salvo is executing), it is possible the system could stop processing routes until a failover or restart of GV Convergent was done.
- [Ref. #PEG-10922] **GV Convergent database migration issue if upgraded from an old GV Convergent version to v2.1.2:** The issue was encountered while upgrading from an old GV Convergent version to GV Convergent version 2.1.2. The issue affects the migration module.

The recommendation is to upgrade directly to GV Convergent 2.2.0 and bypass version 2.1.2.

#### **GV Convergent Version 2.1.2**

This release adds the following enhancement(s) and corrects the following issue(s).

**New Features and Enhancements** 

- [Ref. #PEG-10745] The default RTP values have been updated in GV Convergent as they were changed for GV Node: the default RTP values have changed in GV Convergent as follows:
  - 2022-6 (Video), RTP = 98 (no change)
  - 2110-20 (Video), RTP = 97 (it was 96 with GV Convergent version 2.1.1 or lower)
  - 2110-30 (Audio), RTP = 96 (it was 97 with GV Convergent version 2.1.1 or lower)
  - 2110-40 (ANC), RTP = 100 (no change)

These values are now used by GV Convergent to build stream SDP information for non-NMOS devices. These values can be changed in GV Convergent if necessary. Please contact Technical Support to do so. See Grass Valley Technical Support, on page 94.

• [Ref. #PEG-10663] GV Convergent to update SDP files for non-NMOS devices dynamically: GV Convergent generates SDP files for all streams of a non-NMOS device with updated parameters sent from the non-NMOS device such as IQ series cards and AudioLive in order to allow takes (IS-05 connection management) between non-NMOS senders and NMOS receivers.

If the non-NMOS devices are not sending those parameters, GV Convergent uses default values and also allows you to edit the SDP files for the streams.

- [Ref. #PEG-10734] GV Convergent Stream Configurator:
  - 1 Ability to build SDP profile templates in GV Convergent and have the ability to apply them to multiple streams given search criteria per device, port and stream so that you can quickly change SDP information of streams in bulk instead of one by one.
  - 2 It is not possible to change the lane IP Address even though GV Convergent allows you to do it.
- [Ref. #PEG-10779] **Ability to configure port redundancy at Device Group level:** a new automation has been added to the Quick Config button, in the Topology Configurator stage, so that port redundancy can be activated by setting a checkbox.

This only applies to IP devices and pairing is done sequentially by port number so that port1 is redundant with port2, port3 is redundant with port4, and so on. If the number of ports is uneven, then the last port will not be redundant. This automation ignores any port that is already redundant with another.

- [Ref. #PEG-10832] Logical source/destination for NMOS devices have the full name of the group hint tags: Logical source/destination labels created for NMOS devices are now using the entire grouping hint tags and are no longer truncated to 8 characters.
   For existing topologies with NMOS devices, GV Convergent will update the logical device short labels so they are no longer truncated versions of the labels.
- [Ref. #PEG-10834] NMOS Logical sources/destinations labels are not overridden anymore with registry updates: Once the logical source/destination is created, by using the grouping hint tags, GV Convergent will not change it anymore and will not keep it in sync with the registry. User can change the labels and they will not be overridden NMOS registry updates.

#### **Bugs Fixed**

- [Ref. #PEG-10689] **DCNM v11.2(1) limitations:** for the new DCNM version 11.2(1), there was a limitation where ports needed by GV Convergent Version 1.2.1 or higher for authentication (5672 and 15672) are blocked by default. With this issue, GV Convergent was not able to connect to DCNM.
- [Ref. #PEG-10789] **GV Convergent does not allow changing the logical level on NMOS senders/receivers:** when an NMOS discovered device is dropped on the topology, the device is populated based on the values in the NMOS registry. As GV Convergent receives update notifications from the registry, it updates the device accordingly.

However, if you explicitly modify some fields/properties, in the GV Convergent device, GV Convergent will not update those property values to keep them in sync with the registry. The sender and receiver logical levels are now part of this exception and wonbe in sync with the registry.

• [Ref. #PEG-10792] **Invalid NMOS destination tally if a non-NMOS source is routed to it:** if a non-NMOS source is routed to an NMOS destination, then the non-NMOS source does not populate the field *sender\_id* field (null) in the subscription of the NMOS receiver. GV Convergent uses this field to establish the source routed to the destination and to display the tally.

If GV Convergent is instructing the take, GV Convergent will associate the appropriate source to the destination and properly display the tally even if the *sender\_*id is null.

But if the take (Non-NMOS source to NMOS destination) is done outside GV Convergent, GV Convergent will keep the previous tally with the previous source because the *sender\_id* is null.

#### **GV** Convergent Version 2.1.1

This release adds the following enhancement(s) and corrects the following issue(s).

#### **New Features and Enhancements**

• [Ref. #PEG-10400] **Panel preset behavior changes:** the way presets are show on panels has changed. Previously, panels were only displaying the presets of the actual takes that were sent to GV Convergent. Now all affected levels will display the resulting tally of the take even if the level is not affected by the current take or is not high tallied. In other words, following the take, if it succeeds, the tally for all of the level buttons, selected or not, will change to what was shown on the preset.

#### **Bugs Fixed**

• [Ref. #PEG-9888] **Some sources can** in some cases, when performing a take from a source with only a Video stream to a destination with both Video and Audio streams, GV Convergent was randomly failing the take instead of succeeding the take for the available levels/streams.

Now GV Convergent will succeed the take and display a warning that only some levels were taken.

• [Ref. #PEG-10682] Slow takes or timeout failure if IP Clean Switch is enabled on the destination: in some topologies, if IP Clean Switch is enabled on the destination, routing to this destination could cause slow takes or even a timeout failure if it takes more than 5 seconds.

Some improvements were made to the pathfinding algorithm, while using IP Clean Switch, to fix this issue.

- [Ref. #PEG-9076] Path manager does not refresh when something is routed to nonprimary stream: sometimes the Path manager did not refresh when something was routed to non-primary stream. Now the Path manager will refresh on any tally change.
- [Ref. #PEG-10694] MADI takes are failing because we couldnseconds: in some cases, MADI takes were failing (timeout failure) because GV Convergent was not able to find a path within 5 seconds.

Some improvements were made to the pathfinding algorithm for MADI to fix this issue.

 [Ref. #PEG-10697] NMOS: GV Convergent uses stream multicast IP address to populate the unicast port IP address of a NMOS Sony device: While evaluating/testing a NMOS Sony CCU device, we noticed that GV Convergent uses a multicast IP address, from an ancillary stream, to populate the unicast port IP address instead of using the port IP address from the same SDP file.

The issue occurred because there was an extra space in the "source-filter" line of the SDP, which GV Convergent was not expecting. SDP parsing was improved in GV Convergent to handle this issue.

- [Ref. #PEG-10705] Unable to log into GV Convergent server using GV Convergent: sometimes, GV Convergent was not able to log into GV Convergent server because it was awaiting for background threads to become available.
- [Ref. #PEG-10706] Selecting levels on panel which donbutton to light up and do all level take: when using a panel with level button, if you selects levels which dontake button will cause GV Convergent to perform an all level take, even though specific levels were selected. The problem was that previously, the take button would light up if an all level take was possible between source and destination, regardless of levels selected. The fix was to check if an all level take is possible only when wedoing an all level take.
- [Ref. #PEG-10372] MCR operator was not able to make any route change from a router control panel: in order to understand some network events/issues that happened recently at some customer sites, GV Convergent has implemented new logs to get more details on different network events to be able to better understand when an IP address conflict happens.

The log improvement is a new special log for periodic "pings" between the two servers and between the servers and the reference address. The rate of this ping is around once per second.

• [Ref. #PEG-10418] **GV Convergent Cluster issue - Duplicate IP detected:** in order to understand some network events/issues that happened recently at some customer sites, GV Convergent has implemented new logs to get more details on different network events to be able to better understand when IP address conflict happens.

The log improvement is a new special log for periodic "pings" between the two servers and between the servers and the reference address. The rate of this ping is around once per second.

- [Ref. #PEG-8040] Topology in Path Manager does not show new tie line created at the output of the switch to the input of the gateway
- [Ref. #PEG-8162] While you add operations in a Salvo, the operations list can become locked
- [Ref. #PEG-8223] **Physical Connections Table Reload button:** if you have selected a physical connection and then activated the topology, the Physical Connections table is stuck at loading.
- [Ref. #PEG-9825] **Changing a destinationdestination to fail:** one you have created a logical destination and then, after performing takes to that destination, you change the logical level of that destination, takes to said destinations may fail.
- [Ref. #PEG-10205] **GV Convergent IP LDX Router Control issue:** the LDX team has deprecated the REST interface that GV Convergent used to implement the LDX driver. IS-04/IS-05 support is now available.

### **GV Convergent Version 2.1.0**

This release adds the following enhancement(s) and corrects the following issue(s).

**New Features and Enhancements** 

- [Ref. #PEG-5858] GV Convergent has implemented the Salvo command for Northbound NP0017: command 3022 was already supported in GV Convergent for sources and destinations, but now the mnemonic type for salvo 0x0005 has been implemented. This allows you to request the salvos configured within GV Convergent and then offer the ability to execute those with a separate command.
- [Ref. #PEG-9092] Ability to filter streams that come from input or output ports in the stream browser of the logical device table: while exposing streams on both input and output sides, if device streams are named the same at RX and TX, there was no way to filter them. Now, there is a filter option in the drop down to show only streams from input or output ports.
- [Ref. #PEG-9611] **Devices that use discovery are now provisioned for in DCNM by GV Convergent:** GV Convergent provisions host policies for devices that are created within the topology. However, until these devices are in the DCNM topology, they could not be provisioned for. This created an issue where devices that used discovery to be displayed within the topology configurator could not be discovered until they were provisioned for.

To address this issue, GV Convergent now provisions a range to allow these devices to be discovered. The workaround had been to manually put the host policy into the DCNM UI.

• [Ref. #PEG-9623] Automatic physical connections functionality for IP devices (Quick Connect) within topology is now available: New Quick Connect button was added to the Topology Configurator. It automatically makes the physical connections for IP devices, within the topology, and also creates the SDI end-points for those IP devices.

Physical connections for IP devices are generally very straightforward but time consuming to do. From the GV Convergent topology, it is easy to know where IP

physical connections should be done because there are always one or two network switch devices.

The UI allows you to identify which network switch(es) they want to connect their equipment on and all of the physical connections will be done in the background taking into account redundant ports.

Click on the new topology automation button in the Topology Configurator toolbar, and select the main and backup networks. Check the begin the process. The progress of physical connections will be displayed.

• [Ref. #PEG-9832] Alias selection for Category Editor: Ability for you to see the alias names used to make categories in the GV Convergent Category Editor Stage.

This is useful when you have created alias(es) and now want to create categories for use on the panels.

Instead of using the generic device name generated by the system, you can use the alias to identify the device.

- [Ref. #PEG-10034] **Megasource: modify the pathfinding rule to match exact logical levels before applying best match logic:** you can now create logical sources where the same or different streams can be added to the logical level columns that share the different custom logical levels. Megasource only applies to sources with multiple stream/level pairings and the filtering happens when a normal destination is used in a route. See the *GV Convergent User's Manual* for more information about this feature.
- [Ref. #PEG-10035] **Optimize pathfinding for 4K devices:** Pathfinding improvements were made to make GV Convergent 4K takes faster.
- [Ref. #PEG-10223] **Default Category parameters and Copy Category Parameters feature added:** One of the more time-consuming aspects of panel configuration was the configuration of categories on the panel. You were required to enter a display mode, exit mode, and panel page where list items or keystrokes were to be utilized. This was needed for each category placed on the panel.

This improvement offers a default setting of Display Mode - "List", and Exit Mode -"Preset". You would then only need to add the page of the list items for the first category. You then would have the ability to select to copy these parameters to all other categories. More information can be found in the GV Convergent User's Manual.

- [Ref. #PEG-10237] Short name for the logical levels now returned through northbound interface: Prior to this improvement, only the long name of the logical levels were returned in response to northbound command for mnemonic requests.
- [Ref. #PEG-10294] **Takes using complex logical devices that require crosspoints/joins on a single device in less than 1 frame:** The single hop performance optimization in GV Convergent currently applied only to sources and destinations that have a single stream and level.

With more complex logical devices that have more levels and streams, the single hop algorithm was not used and fell back to the pathfinding instead. In many cases, like 4K or 2110 takes, the resulting commands are only simple crosspoints on a single device but because pathfinding was used, the takes happened within 2-4 frames.

Now, the single hop restriction is more permissive. As long as all the destination level/stream pairs are satisfied by the source, GV Convergent attempts a single hop fast take before using full pathfinding.

• [Ref. #PEG-10347] **Support routing audio signals through an IQAMD card:** The IQAMD card is an audio-only gateway that can convert SDI MADI audio signals to AES-67 and vice-versa.

Discovery of the IQAMD and its receivers is already supported since itand now GV Convergent is able to read the audio configuration so that the proper levels are set on the SDI and IP ports of the device for the multiple types of audio configurations for SDI and IP.

- [Ref. #PEG-10365] Support IQAMD use case where the extended headers are not used: If the extended headers are not used in the topology, GV Convergent must route the channel count from the audio IP source to the IQAMD card.
- [Ref. #PEG-10367] Ability to rename automatically generated sources and destinations in bulk: In the Logical Device Table and Alias Editor, sources and destinations labels are displayed but previously you were not allow to edit them. In the case of the Logical Device Table, only custom logical device labels are editable.

In a system where there are thousands of logical devices, this limitation made it cumbersome to configure.

Now automatic sources and destinations can be renamed and it is possible to do so by bulk pasting content from a spreadsheet into the alias editor as it is done for aliases.

- [Ref. #PEG-10420] **SDP field is editable for IQ devices:** the SDP field for IQ devices, including Audiolive, are editable should there be a need to update a parameter.
- [Ref. #PEG-10494] Improve GV Convergent logs to get more details when duplicate Virtual IP address conflicts happens: in order to better understand some network events/issues that have occurred at client sites, GV Convergent now has implemented a new log that shows more details about network events to be able to better understand when IP address conflict happens. Now there is a special log that captures the periodic "pings" between the two servers and between the servers and the reference address. The rate of this ping is around once per second.
- [Ref. #PEG-9768] Ubuntu OS latest patches have been updated to the image for 2.1.0: Due to security concerns, the Ubuntu OS patches have been updated in the production image for GV Convergent version 2.1.0.
- [Ref. #PEG-9818] **GV Convergent Power Supply Unit (PSU) status added to the System Status tab:** IPMI Tool was added to GV Convergent server to fetch the IPMI status and the old tool FreeIPMI was removed.

The PSU status is reported like a Fan status on the System Status tab. You will need to reboot GV Convergent server once after upgrading to GV Convergent version 2.1.0 to activate the new driver and to see the correct the PSU status in GV Convergent. You also must ensure that a GV Convergent server equipped with redundant PSUs, in order for the server to do a one time detection for the redundant PSU configuration, has both PSUs installed and powered up in the server during the reboot for both PSUs to allow them to be detected.

## **Bugs Fixed**

• [Ref. #PEG-9817] Takes long time to load the router control tab: in previous GV Convergent versions, if a topology has many sources/destinations (more than 2000), opening the router control tab took a long time before loading all the logical sources/destinations.

- [Ref. #PEG-9981] **Panels: Category Exit Mode not working properly:** In GV Convergent Panel Configurator, each Category property has an Exit Mode selection. The available options are Never, Preset or Take. When the Exit mode is set to Preset and the member of the category is a source, the Exit Mode works correctly after the selection of a source (preset). The panel returns to the state prior to entering the category. When the member of the category are destinations and a destination is selected, the panel destination changes to the selected destination. However the panel does not return to the state prior to entering the category. It remains in the member selected state. You need to select the "Previous" button to exit out of this state. For a category with large number of members, you will need to select the Previous button a number of times in order to exit. This behavior was seen in GV Convergent version 1.9.0.
- [Ref. #PEG-10202] GV Convergent 4K Take is slow: pathfinding improvements were made to make GV Convergent 4K takes faster.
- [Ref. #PEG-10217] **GV Convergent failed to take Quadlink 4K between K-Frame and IQUCP:** GV Convergent is no longer failing 4K takes between K-Frame and IQUCP.
- [Ref. #PEG-10230] Random slow response time when VSM control GV Convergent for switching: pathfinding improvements were made to make the switching faster.
- [Ref. #PEG-10292] NV9647 list items were being duplicated when utilizing more than two rows: This issue was found to exist in panels other than the NV9647, but has been resolved. The first two lines would display the correct device names in the list items for categories. However, if you configured more than two rows to be used for list items, the first two rows would be duplicated on the following two. This may have also been occurring with duplicated columns.
- [Ref. #PEG-10393] Database restore timeout is now 10 minutes: in order to accommodate larger configurations, the timeout that occurs when restoring a database via the administration web page has been increased from 3 minutes to 10 minutes. If there is a problem when loading the database, it will now take 10 minutes before falling back on the previous database and showing an error message.
- [Ref. #PEG-10414] Incorrect Path Views in GV Convergent when routing the First Pair of MADI Audio tracks to MADI destinations: improvements were made to Pathfinding while comparing level families. Now, the Path Manager shows the appropriate path.
- [Ref. #PEG-10419] Route Error when routing from a Node SDI to an IPG-4901: fixed an issue which could prevent takes from working when changing the logical level of an IPG
- [Ref. #PEG-10440] Sometimes takes timeout if there are too many different source streams for a destination: improvements were made to the Pathfinding algorithm.
- [Ref. #PEG-10485] **GV Convergent and panels went down for about 3 minutes:** the issue occurred when a duplicate Virtual IP address conflict happens. This is now fixed in GV Convergent version 2.1.0.
- [Ref. #PEG-10490] **GV Convergent Does not provide status on all devices when asked via NDAC NP0017:** the response to the Get Simple Device Status (0x00003017) for "all levels" of more than one device would only return the information for the last one requested.
- [Ref. #PEG-10498] **GV Convergent fails to complete the population of some windows:** some improvements were made to reduce GV Convergent slowness and new logging to help investigation if it happens again in the future.

- [Ref. #PEG-10504] **Fixed server side performance degradation over time:** server side performance could degrade after a large number of configuration modifications were performed. This resulted in above normal server load leading to unresponsive clients and slower takes. Performance was only restored after a restart or fail over.
- [Ref. #PEG-10527] MADI to MADI across Node routes not working: Local MADI in to MADI out routes work but MADI to MADI across Node routes was returning an error. Now, MADI to MADI takes across nodes are working as expected.
- [Ref. #PEG-9593] When dropping a discovered device on topology, the device group is not made unique: any element on a topology must have a unique name. When dropping a discovered device on the topology, the label is now made unique.
- [Ref. #PEG-9900] **Creating a duplicate panel configuration can create a dysfunctional panel:** using buttons such as load pages and categories that jump to list or keystroke pages, and then copying that configuration to another panel may cause these listed buttons to not jump to the correct panel configuration. This has been corrected and the panel copy from an existing configuration functionality has been restored.
- [Ref. #PEG-10127] **Update to the GV Convergent Health Status made available to iControl:** iControl uses a REST interface to pull the Health Status information that is displayed on the System Status Stage in the GV Convergent. The interface was updated to accommodate the latest available status in GV Convergent.
- [Ref. #PEG-10175] You can now rename Virtual Crosspoints in the Logical Device Table: this improvement corrects a minor oversight with regards to virtual crosspoints allowing you to rename them after they have been created.

## **New Features and Enhancements**

- [Ref. #PEG-9544] **GV device to SAM device switching is now working:** an issue that found the flow type to not be appropriately set on SAM edge devices when joining 2110 senders from Grass Valley devices has been addressed. This allows for all supported SAM devices to correctly join Grass Valley devices.
- [Ref. #PEG-9551] **GPIO configuration and control are now available in GV Convergent:** there is a new stage GPIO that has been created in GV Convergent. This stage will allow you to configure GPI and GPO connectors on the NV Panels. The GPI closures can trigger Salvos and takes by transitioning from off to on and on to off. A boolean logic editor has been added with scripting to create the logic for GPO. More information is available in the GV Convergent User Guide version 2.0.0.

• [Ref. #PEG-9816] Code migration has been improved to support the upgrade from versions that are earlier than just the previous software release: prior to this release of GV Convergent, migration code that accommodated the upgrade from earlier releases was only able to upgrade from the most recent full software release of GV Convergent code. With the release of GV Convergent v2.0.0, you can now upgrade directly from version 1.3.0 and above without having to upgrade incrementally. Any migration issues that may have existed when upgrading incrementally have been addressed in the GV Convergent v2.0.0 release.

The time it will take to re-connect to the GV Convergent server via the GV Convergent may take a long time depending on the current size of the topology. In some cases it took up to 15 minutes for the migration code to complete it task.

 [Ref. #PEG-9851] New AES-67 logical levels have been created to ease configuration: in order to create devices with non-standard audio profiles, additional logical levels were created and are shown on the logical level editor. Upgrading to GV Convergent v2.0.0 will also migrate to these new logical levels. This means that if you have created additional logical levels, GV Convergent will create additional user-defined logical levels for the AES67 versions.

The AES67-16 logical level is equivalent to the existing SDI Audio logical levels.

- [Ref. #PEG-9898] **iControl bundles added to support the version 3.0.0 of GV Node:** the bundles support the command changes that will allow GV Convergent to communicate with GVN 3.0.0.
- [Ref. #PEG-9988] Update of NMOS grouping tags for creating and controlling devices: final version of grouping tag:

- [Ref. #PEG-10053] Added ability to change the configuration of logical levels on Audio Live outputs: by exposing the outputs of Audio Live for you to change the logical level, you can create paths for conversion to take place between audio profiles. The input of Audio Live can accept any AES67 audio profile. You can identify the logical level of the Audio Live output interface that will match a destination device. If the source does not have a compatible logical level, but the path is available, the GV Convergent Pathfinding with use a path through Audio Live to convert the audio to match the destination device.
- [Ref. #PEG-10222] **SDI logical levels can share common logical levels:** in order to create additional user-defined logical levels, you must duplicate the existing system-defined SDI logical level. This will create a copy of all of the child logical levels contained within the SDI logical level. You can now change the logical levels contained within the duplicate logical SDI levels. Use cases include creating video or audio logical levels for compatibility reasons (SD, 3G, audio profile C, audio profile A). The video logical levels could contain the same type of audio logical levels. This will require less level buttons on the control panels to perform breakaway and shuffling.

## **Bugs Fixed**

- [Ref. #PEG-10096] "No Tieline Available" error was displaying unnecessarily: an issue with the pathfinding algorithm created the situation where not all paths were attempted prior to reporting back this failure. This issue was corrected.
- [Ref. #PEG-10097] System Snapshot failure addressed for logs and configuration capture:

Resolution: The snapshot implementation was unreliable and could have random failures, especially when the process takes longer (for example, when database is large).

There were multiple causes for these failures:

- 1 The generation of the routerInfo.json file (router information in the database) can fail to complete because the output buffer was not consumed.
- 2 The snapshot zip file was sent over http incrementally as it was built, increasing the chance of timeouts and download failures.
- 3 The web pageand when recovered, forces a reload of the home page, closing the current session and any pending downloads, causing them to fail. This applies to snapshots as well as backups.

Fix Summary:

- Build the snapshot zip file completely on the server before sending it for download.
- Read the output buffer of executed shell commands to avoid blocking.
- Donfailure.
- [Ref. #PEG-10136] Tieline bandwidth usage now more active for exposed streams: when you use exposed streams, the tieline associated with the path from the transmitter or receiver to/from the network switch would be displayed as utilized. The implemented improvement now only displays the path used when a take involving that path is used. This more accurately displays the bandwidth capacity that can be seen within the Path Manager Stage in GV Convergent.
- [Ref. #PEG-8716] Unique bug involving missing physical connections after failover has been resolved: after a failover, the topology may have missing physical connection information within the GV Convergent. This issue has been resolved in version 2.0.0.
- [Ref. #PEG-8830] Stream browser now shows expected streams after deleting a destination edge device: deleting a device group does update the table for that corresponding device. However, formerly, if we switch to the other tab (Sources or Destinations), the Stream Browser was empty. This issue has been resolved in the code and will no longer occur.
- [Ref. #PEG-9961] Flow type is now no longer editable by you it is now set by the logical • level: the flow type field that is used to define SDP information for IS-05 connection management, in the device properties, is now set only by editing the logical level of a device stream. The video flow type would be used for SDI or other video logical levels. Audio flow type will be utilized for SDI audio, AES-67, and other audio logical levels. Data flow type will display for ancillary and other ancillary logical levels.

• [Ref. #PEG-9755] **GV Convergent now has ability to control the K-Frame IP receivers:** The K-Frame team has provided the ability of GV Convergent to control the IP receivers of the switcher frame. This, coupled with the GVG Native Protocol external interface allows for the complete integration with the K-Frame switchers. The switcher operator can pull mnemonics from GV Convergent and issue commands to GV Convergent to join source streams to the K-Frame IP receivers. This supports 2022-6 and 2110 modes of operation with 2022-7 media network redundancy. The K-Frame switcher will be a virtual device that can be added to the GV Convergent topology and present its receivers as destinations, its transmitters (the output of the switcher) as sources.

Configuration of the K-Frame switcher can be found in the GV Convergent User Guide for version 1.10.0 under the topic *Configuring a K-Frame Production Switcher*.

• [Ref. #PEG-9760] **SDP information generated for non-NMOS discovered devices:** In order to use IS-05 connection management, SDP information is required to be sent as part of the command. Most devices configured within GV Convergent were not discovered using NMOS IS-04, and therefore did not have native SDP information. Thus, GV Convergent needed to created that information for those devices that do not generate and publish their own information, in order to utilize the IS-05 connection management commands to discovered NMOS receivers.

The SDP information is now generated by GV Convergent and is included in the connection management commands to allow discovered AMWA NMOS receivers to join non-discovered senders, or source devices created within the GV Convergent.

This SDP information is not currently published to the AMWA NMOS registry, but may be in the future.

 [Ref. #PEG-9891] GV Convergent Control of Kaleido-IP supports both 2022-6 and 2110-20 modes: NMOS video receivers are reported merely as "video". GV Convergent didnregards to path finding and logical level assignment. NMOS receivers accept either a 2022-6 (that is, SDI logical level) or 2110-20 (that is, V logical level) signal. The GV Convergent pathfinding code was altered to allow either logical level sender to be joined by the Kaleido-IP receiver.

### **Bugs Fixed**

- [Ref. #PEG-9773] Logic was updated in the Web Admin to prevent access to directories on the Server: The logic was updated in the Web Admin access to prevent you from accessing directories that you should not have access to. This will ensure that strict routed file paths are enforced.
- [Ref. #PEG-9774] **Improved security with regards to Apache Felix GoGo:** Development has disabled the OSGi debug console by default for production GV control systems.
- [Ref. #PEG-9908] **Invalid shuffle takes no longer lock up system:** an issue that was found where you could attempt to shuffle audio, where there was not a demux/mux path to allow for this action to occur, that may cause the panel or client to lock up. This will be further optimized in a future release, but for now, the system should no longer lock up.
- [Ref. #PEG-8897] The GV Node streams for audio and ancillary flow types default to video: An issue within the code was corrected to correctly set the flow type device property. The device property was defaulting and remaining at video for all logical levels. The issue has been resolved by setting the appropriate flow type based on the logical level of the stream video, data, or audio.
- [Ref. #PEG-9664] Fixed an issue where wrong logical device configuration caused failed takes: When configuring logical devices, if you configure streams under the incorrect logical level, in the logical device table, then attempting to execute takes with those devices was causing future takes to fail. This has been corrected in the code and while the initial take may fail with the incorrectly configured devices, it will not impact future takes of correctly configured devices. The failures will be indicated within the Audit log.
- [Ref. #PEG-9695] Discovered NMOS devices may need to update audio depending on its grouping: GV Convergent no longer treats the multiple streams of same type, from the Kaleido IP, as sub-levels. Only the first stream (sorted alphanumerical) will be assigned. For example, a KIP has a video and 4 audio streams (a1, a2, a3, a4) under the group tag <source name>. A logical destination named <source name> will be created with the video stream assigned to level V and "a1" assigned to level A (which is a composite logical level that contains all 16 channels of audio). • [Ref. #PEG-9495] **Spine to Leaf aggregation link capacity displayed in GV Convergent Path Manger:** path manager un-managed topology now displays bandwidth usage percentages between spine and leaf. This information is resolved using an API call to the switches.

- [Ref. #PEG-9637] Added support for redundant router support with Probel SW-P-08 southbound: this functionality has been added and tested against the Sirius Router.
- [Ref. #PEG-9405] **XY status button added to panel button options:** the XY status button will display the status of the currently selected destination. This allows you to know what destination is selected as they navigate through pages on a panel that does not have a display. The XY status button displays the same data as a standard destination button, but only for the currently selected destination on the panel where the button has been placed.

#### **Bugs Fixed**

- [Ref. #PEG-8241] DCNM v11 has addressed several issues that will improve GV Convergent path visualization: several issues that existed in path visualization that were related to vendor specific issues have been addressed. One of these issues involved displaying duplicate network switches.
- [Ref. #PEG-9135] **DCNM v11 integration addressed an issue with DCNM redundancy:** an issue was addressed where GV Convergent failed to connect to the redundant DCNM controller in an HA (high availability) configuration.



Virtual sources that have a 4K source routed to the corresponding virtual destination can not be routed to non-4k destinations.

- [Ref. #PEG-9448] **DCNM v11 integration now supported in GV Convergent:** The updating of the integration between GV Convergent and Cisco DCNM v11 has been completed. For more information on this integration, see the GV Convergent User Guide guide for v1.8.0.
- [Ref. #PEG-9490] You can now create multiple virtual cross points at a time: the Virtual Cross Point functionality, added in a previous version of GV Convergent, has been improved to allow you to create more than one virtual cross points at a time. You provide a prefix, an index starting value, and an ending index value for the virtual cross points, to create a series of virtual cross points. The ending index will allow for you to skip creation of virtual XPTs that already fall in between the range of indexes.

• [Ref. #PEG-9585] Features now disabled in the Web Admin of GV Convergent that are not allowed to be done when a redundant cluster is intact: Features that require a restart of the control software will now be disabled from the GV Convergent Web Admin pages if the GV Convergent servers are in a redundant cluster. These features are upgrades of the software and restoration of backup configurations.

GV Convergent now supports making a back up without breaking the cluster or restarting the control software.

**Bugs Fixed** 

- [Ref. #PEG-9229] Improvement made to category list pages for NV panel configurations: An issue has been addressed that created a situation where category list pages in NV Panel configurations did not display the total possible devices on the list page after selecting previous from a list page that did not utilize the total number of devices.
- [Ref. #PEG-9570] Adjusted tolerance for discovering IS-04 devices that have improper header: In order to support IS-04 AMWA NMOS devices, GV Convergent adjusted its tolerance to handle messages from devices publishing non-standard headers. This tolerance will allow GV Convergent to discover devices that have not followed the standard exactly with regards to content-type.
- [Ref. #PEG-9101] Host Names now change when the Network Host Name is altered in GV Convergent: This issue was resolved as part of the DCNM v11 integration.

- [Ref. #PEG-9298] Issue where two host policies may have been created after modifying multicast IP resolved: This issue was resolved as part of the DCNM v11 integration.
- [Ref. #PEG-9470] **Discovered SAM devices are now given a unique name when added to the topology:** Previously there was not a unique device name for the discovered devices. This release adds the following enhancement(s) and corrects the following issue(s).

## **New Features and Enhancements**

- [Ref. #PEG-4812] Removing a logical destination device from a virtual XPT changes the status to the logical source device: while adding a logical destination device to a virtual XPT changes the status of the destination to the virtual source with the logical source device content being routed to the logical destination device. Removing the logical destination device from a virtual XPT, will change the status of that destination to the logical source device.
- [Ref. #PEG-4843] **GV Convergent now supports the IPG-4901:** this feature introduces the IPG-4901 device in GV Convergent. The IPG-4901 is an IP gateway card that resides in the GV Node. This card allows you to expand the receivers available on the GV Node, as well as it brings more flexibility to the allowed audio profiles that can be accepted through the IPG-4901.



#### To configure the device:

- Drop it on the topology from the Virtual Devices library
- Configure the GV Node IP Address and Slot Number properties under Device Properties
- When the topology is activated, the card configuration is read from Densite Manager and applied to the device.

#### To connect the device:

- IPG 4901 has 9 SDI input ports, 9 SDI output ports, and 2 bidirectional ETH ports
- The SDI ports must be connected to the SDI ports of the GV Node in which the IPG-4901 is slotted in


- This rule is not enforced in GV Convergent. It could be possible to use IPG-4901 like 3901 however this is not a valid use case.
- The 9 SDI input ports short labels are called OUT for OUT from fabric, and the 9 SDI output ports short labels are called IN for In to fabric to follow iControl's behavior.


- They are divided similar to IPG-3901
- It is possible to assign a logical level to SDI ports by changing the Logical Level of SDI stream at the Gateway level
- It is possible to assign a logical level to IP streams by changing the Logical Level on ETH stream on Stream level, under Gateway
- It is possible to change the multicast address for SDI to IP gateways (called OUT) by changing the IP Address, Port, Redundant IP Address and Redundant Port


- In OFF or Redundancy mode, gateways OUT 6 to 9 and IN 6 to 9 are disabled and not visible in property editor. They become visible only if card is in Aggregation mode.

• [Ref. #PEG-9052] Actual and GV Convergent reserved memory now displayed in System Status stage: prior to 1.7.0, only the reserved memory resources of the GV Convergent server were displayed in the System Status stage. The actual memory usage is now displayed, as well as the reserved memory.



• [Ref. #PEG-9078] **Densite Conrol Ports are now active on the inactive GV Convergent server:** on the system status page inside the GV Convergent, the Densite Gateway control points would status as standby until the release of GV Convergent 1.7.0. Those control points are now active on the inactive controller and will status accordingly. This improvement will allow for shorter fail over times between GV Convergent controllers. • [Ref. #PEG-9132] **Discovered Devices expanded to support SAM product integration:** the SAM devices will now be displayed in Discovered Devices section of the Topology Configurator. The discovered devices that were created to display IS-04 discovered devices, was expanded to support SAM devices discovered with development performed for SAM product integration. Once you drag the discovered device into the topology and creates the physical connection link, the configuration for the devices will be complete. You would then only need to create the edge devices (SDI and IP devices) that are connected to the SAM product. The integration will support the IQMIX card for 1.7.0. Integration with IQUCP and MV-820 will be forthcoming in 1.8.0 of



 [Ref. #PEG-9133] Initial SAM integration added to GV Convergent: SAM IQMIX can now be discovered and added to the topology within GV Convergent. For the 1.7.0 release, only SAM devices can be routed to other SAM devices to accommodate other integration efforts that are forthcoming in future releases.

You can discover the IQMIX and add it to the topology, creating the physical connections with the network and other devices to control the edge device.


- [Ref. #PEG-9276] **Updated mapping of NMOS devices:** improvements of the NMOS mapping include grouping parameters and interface bindings to create ports assigning senders/receivers to those ports.
- [Ref. #PEG-9336] **TCP/UDP port property of router drivers for southbound control are now configurable:** the hard-coded ports of southbound routers and router control systems has been amended to allow for configuration. Sometimes a vendor may use a protocol, but not utilize the default port. This will allow you to change the configuration to match the port specified by the southbound router.

• [Ref. #PEG-9337] Virtual XPT reset button added to the Router Control UI stage in GV Convergent: the virtual XPT reset button is now available in the Router Control UI that allows you to reset the virtual XPTs. This will essentially replace the salvo for the initialization of the virtual XPTs. The procedure is to select the virtual XPT and click on the reset button. This will route the appropriate virtual source to the real destinations statically configured in the virtual XPT tab of the logical device table.



- [Ref. #PEG-9338] Virtual source and destination filters have been added to GV Convergent: this will allow you to filter on virtual XPTs when configuring the panel, categories, and the router control UI.
- [Ref. #PEG-9408] Logical destination can only be added to one virtual XPT: a real destination can only be added to 1 virtual destination. Once added, it should no longer be available to other virtual destinations.

A Pop up confirmation message is exposed if you are trying to add a logical destination that has already been added to a virtual XPT. The toaster popup will be part of the selector window.



If you select new virtual XPT.

- [Ref. #PEG-9419] Virtual Sources can be routed to unrelated virtual destinations: you can route virtual sources to virtual destinations that are not associated with the same virtual XPT. This allows you to increase the number of logical destinations devices that can be switched with a single route. Routing a logical source device to the virtual destination of a virtual XPT will route said source to all logical destinations devices that the virtual source is routed to. Routing that virtual source to another virtual destination, will mean routing the original logical source device to all destination devices that the corresponding virtual source was routed to, as well.
- [Ref. #PEG-9421] Adding a destination to a virtual cross point in the logical device table should automatically trigger a take: there is a new configuration in 1.7.0 for Virtual XPTs within the logical device table. Once you create a virtual XPT, you have the option to add a logical destination device to the virtual XPT. Doing this will route the virtual source of that virtual XPT to the real destination(s) that were configured for said virtual XPT. This replaces the need to have a salvo to initialize the virtual XPTs.
- [Ref. #PEG-9422] **Deleting virtual XPTs updates status of logical destination to the logical source device routed to the virtual destination:** the logical destination devices that have the virtual source routed to them are updated to the logical source device when the corresponding virtual XPT is deleted.
- [Ref. #PEG-9424] Limit of static configuration of real destinations related to a single virtual XPT is 100 devices: you are able to establish static relationship between the virtual source and up to 100 real logical destinations in the logical device table. Once the logical destination is placed in the virtual XPTs list, the virtual source related to the virtual XPT will be routed to the real logical destination(s).

This functionality replaces the need for the virtual XPT initialization salvo.

- [Ref. #PEG-9458] Virtual XPT status will be displayed in the Path manager: the status of the virtual XPTs will be displayed in the Path Manager.
- [Ref. #PEG-9547] Northbound Controller Client Maximum default set to 100 clients: the GV Convergent can now accept a maximum of 100 clients of northbound control. The value was defaulted to 16. This value is also configurable through ssh interface, if necessary. GV Convergent recommends not exceeding the number of clients above 300 for any reason.

#### **Bugs Fixed**

- [Ref. #PEG-9074] Native Client Installer not downloading from Web Admin after upgrade: after changing the management IP address of a server, the client installer did not work. You receive a connecting... message at the bottom of the browser and nothing happened after that. This is no longer the case and this works correctly.
- [Ref. #PEG-9228] Broken Path Manager when executing a salvo take (one source to all destinations) while selecting Destinations: this is no longer the case and this works correctly.
- [Ref. #PEG-9380] **No Duplicate IP message in the GV Convergent UI:** this was a regression where GV Convergent was logging the warning, but not displaying it properly in the UI. This has been addressed and will display in the UI for duplicate IP addresses.

• [Ref. #PEG-9493] **TICO logical level is being removed and replaced with SDI:** you can still create a TICO logical level if they need to for compatibility reasons, but the TICO logical level will be replaced by the SDI logical level for existing configurations. The logical level, TICO, was creating compatibility issues for customers that did not want to differentiate between SDI and TICO signals. The migration of TICO to SDI logical levels should be automatic.

- [Ref. #PEG-5910] Aliases can be utilized on the panel configurations to display up to 24 characters: 24 character name sets are now available in GV Convergent for the NV panels. See the GV Convergent User Guide for more information.
- [Ref. #PEG-6544] Utilization of the panel display now available for Level Status for the NV9640, NV9642, and NV9647: the implementation of the display for level status of selected destinations is now available for the NV9640, NV9642, and NV9647 control panels. Multi-selection display functionality will be available in a future GV Convergent release.
- [Ref. #PEG-6673] A new device property has been added to display MADI ports on port 8 and 9 of XIO-4901 card for GV Node: see the GV Convergent User Guide for more information.
- [Ref. #PEG-7412] NMOS IS-05 Connection Management is now available: the IS-05 Connection Management standard allows control of receivers to join senders that have been discovered utilizing the IS-04 standards for discovery and configuration. The IS-04 discovered devices are available to be placed onto the topology configurator from a Discovered Devices list that is now available next to the Virtual Devices list. Once you select a discovered device to be added to the topology and makes the physical connections for that device, the configuration will be completed based on that AMWA devices SDP information. Receivers that have implemented connection management can then issue IGMP joins based on connection management messages sent to this receiver.
- [Ref. #PEG-7749] **GV Convergent External Native Protocol from GV Stratus is now available:** GV Status can now communicate with the GV Convergent system to pull names from the GV Convergent database to establish router control. Stratus can then send take commands to cause GV Convergent to make routes feeding media servers also controlled by Stratus.
- [Ref. #PEG-8462] Filter on MADI port type in the physical connections editor: MADI has been added to the SDI and IP port types in the physical connections editor. This will allow you to filter on the MADI port type to display only those connection types when making physical connections on the physical connections editor.

• [Ref. # PEG-9046] Create a panel configuration from an existing panel configuration: a duplicate button has been added in the panel configuration stage. This will allow you to create a new panel configuration based on an existing panel configuration of the same type. The new panel configuration will have a new name and any changes to that configuration will not affect the original panel configuration that you based its configuration on.

You can use the exact same configuration for a panel by selecting the existing panel behavior in the topology manager for the panel Device Group Properties under # *Devices*. Changes to this configuration will affect all panels that share the behavior.

- [Ref. # PEG-9111] **Streams can now be filled in horizontally and vertically on Logical Device Table:** selecting numerous streams and then dragging them onto the logical device table would fill those streams vertically under a single logical level. However, when dragging audio streams, you may want to fill in the streams horizontally for a single device. This is now available by selecting the single row, you can fill in the selected streams horizontally for a single device. Selecting a number of rows will still allow you to define streams under a single logical level, or fill them in vertically. This latter functionality differs only slightly from 1.5.0, where you did not need to first select the rows to drag streams into.
- [Ref. #PEG-9165] Can now set MADI ports on port 8-9 of GV Node XIO cards in topology: this is part of the MADI implementation. Once set, these will allow for SDI devices to be connected using the MADI connector type. The MADI streams can then be assigned to logical sources under the audio logical levels
- [Ref. #PEG-9224] **Disable automatic sources and destination as default for MADI port streams:** MADI port streams will not have automatic source or destinations by default. The ports defined as MADI will create MADI streams that can be placed within manually created logical devices.
- [Ref. #PEG-9227] **MADI is now supported on a GV Node operating in 2022-6 mode:** by defining the disembedders and embedders as enabled/disabled, the pathfinding has been evolved to allow for switching of audio in a GV Node that is operating in 2022-6 mode. It was the case that the embedders and disembedders were assumed to be always off, prior to this release.
- [Ref. #PEG-9231] **GV Node Router Standby issue resolved:** an issue that presented itself with the active or inactive control system displaying a GV Node router connection as standby when this connection should always be active has been resolved. A minor change to the GV Convergent code was implemented to accommodate a state where GV Convergent found itself in a state of receiving the response from GV Node, but not processing the message.
- [Ref. #PEG-9244] Fixed 4K logical device takes regression: An issue that only saw one of the 4 video logical levels taking in a 4K logical device take, has been resolved with this release. See Creating a 4K Switching Setup in the GV Convergent User Guide.
- [Ref. #PEG-9324] NMOS IS-04 Discovery must be enabled in the Area Configurator: When clicking on the System Controller within the Area Configurator, you must click to enable the IS-04 discovery. This feature is defaulted to off.

## **Bugs Fixed**

• [Ref. #PEG-7879] Get HTTP 401 Unauthorized when connecting on DCNM server during startup

- [Ref. #PEG-7967] **Deleting an alias column in the Alias Editor is not reflected in the Router Control UI:** After you delete an alias column in GV Convergent > Alias Editor while the Alias is selected in Router Control UI, the alias is still shown in Router Control UI although expanding the list will not show it as a list item.
- [Ref. #PEG-7994] Aliases disappear after an alias column is deleted: When you delete Alias columns, then add aliases on a new column, and then add another Alias column, the alias labels disappear from the cells.
- [Ref. #PEG-8763] **IP validation: DCNM policies are not created for a valid IP port:** DCNM-Managed network switch connections must be made on the same device. When you create physical connections between a device and a DCNM-controlled network switch, ensure that the matching in and out ports of a switch are connected to the same device. For instance, in1 and out1 of a network switch cannot be connected to different devices because, in reality, there is only a single port and it cannot be connected to two places.
- [Ref. #PEG-9074] **Cannot download client after modifying the server IP address:** After changing the management IP address of a server, the client installer does not work. You get a connecting... message at the bottom of the browser and nothing shows up after that.
- [Ref. #PEG-9215] Data entry may not display on the alias editor fields after deleting an alias: If after deleting an alias column, a new one is created to take its place, entering aliases in the cells may not show the text.

This release adds the following enhancement(s) and corrects the following issue(s).

## **New Features and Enhancements**

- [Ref. #PEG-7528] **SDP for Redundant Streams Merged into One Message:** This option will allow for SDP information for redundant streams to be included within one message. This option should cover more use cases than other options. This follows the RFC 7104 section 4.2 standard.
- [Ref. #PEG-7783] **NMOS IS-04 Query Service Implemented in GV Convergent:** In version 1.4.0 of GV Convergent, you were given the option of selecting a registry to query or utilize the GV Convergent registry. You could also define the GV Convergent registry priority for use in a multiple registry environment. This issue supports the ability to query the highest priority registry for changes in AMWA devices. Those changes will be reflected in the GV Convergent topology.
- [Ref. #PEG-7796] **GV Convergent now supports DCNM 10.4(2) with AMQP v2:** DCNM 10.4(2) introduced the AMQP v2 messages for asynchronous reporting from the DCNM network controller. GV Convergent now utilizes these messages for quicker status updates of the network controller state changes. This will limit the polling required by GV Convergent of the DCNM network controller.
- [Ref. #PEG-8271] **Refresh button, for DCNM flow status, removed from the Path Manager stage:** With version 10.4(2) of DCNM, Cisco has provided the use of AMQP v2 messages that will provide flow status and other updates without polling the network controller. This has deprecated the need to refresh that status and poll for changes.

- [Ref. #PEG-8434] There is a new pop out window for selection of logical levels: The selection of logical levels now uses a pop out window rather than a drop down selection.
- [Ref. #PEG-8499] Additional stream information is now available in the Logical Device Table: Every stream in the stream browser will display the info icon (i) in the top right that, when selected, will reveal the following additional information about that stream:

- [Ref. #PEG-8559] **GV Node support of TR-03 X6 redundant mode:** With GV Node firmware 2.2.x, the TR-03/2110 mode will be enhanced to support 6 streams(X6) per Ethernet lane (10GB interface). Firmware 2.0.x and 2.1.x supported only 3 streams(X3) per port in TR-03 mode.
- [Ref. #PEG-8813] **GV Convergent updates the DCNM visualization to reflect changes in flow due to failed links:** If a link between spine and leaf goes down, DCNM should migrate flows that are using the down aggregation links to other available aggregation links. In Cisco DCNM 10.4(2) we have a notification that the flow migration happened. GV Convergent should update the DCNM visualization to reflect the change in Path manager.
- [Ref. #PEG-8889] Audio Shuffle in Configuration is Now Available in the Logical Device Table: Simple steps to create a logical source with embedded shuffle:

  - 3 Drop Cam1 stream to SDI column for MySrc1.
  - 4 Scroll to the right to view audio1 column.
  - 5 See the little shuffle icon appear in the column headers for audioX.
  - 6 Click the shuffle icon in the audio1 column header.

- 7 The logical level selector appears.
- 8 Select audio3 then OK.
- 9 See the little shuffle icon appear in the cell for audio1 for MySrc1, and that the text in the box now shows A3 (the shuffled source).
- 10 If you do a take from MySrc1 to Mon1 destination, you should see one to one match for all levels except that A3 from the source should be brought to A1 for the destination:
  - Cam1/SDI-V-ANC -> Mon1/SDI/V-ANC
  - Cam1/SDI/A3 -> Mon1/SDI-V/A1
  - Cam1/SDI/A2 -> Mon1/SDI-V/A2
  - Cam1/SDI/A3 -> Mon1/SDI-V/A3
  - ...

### Create logical source with embedded breakaway and shuffle:

- 1 Add a new logical source "MySrc2".
- 2 Drop Cam1 stream to SDI column for MySrc2.
- 3 Drop Cam2 stream to audio1 column.
- 4 Click shuffle for audio1 column and select audio3. Since there is a breakaway at this level, the shuffle will apply to this breakaway source.
- 5 If you do a take from MySrc2 to Mon1 destination, you should see:
  - Cam1/SDI-V-ANC -> Mon1/SDI/V-ANC
  - Cam2/SDI/A3 -> Mon1/SDI-V/A1
  - Cam1/SDI/A2 -> Mon1/SDI-V/A2
  - Cam1/SDI/A3 -> Mon1/SDI-V/A3
  - ...

#### The logical level selector (when click on the shuffle icon in the column headers):

- The title of the logical level selector includes the name of the level column that the icon was clicked on.
- When opened, if there was already a shuffle defined for that column, the shuffled level is pre-selected.
- The OK button is disabled if there is no change in value.
- If the column had no shuffle defined, there is nothing pre-selected, and the OK button is disabled until a level is selected.
- If the column had a shuffle to audio3 defined, then audio3 is pre-selected, and the OK button is enabled if audio3 is deselected or another level is selected, but it is disabled again if audio3 is re-selected.

#### When editing logical source/destination:

- The shuffle icon only appears in the column header if the selected row:
- is a custom source/destination (not a factory generated source/destination)
- there is a stream (either explicit or inherited) at that level (i.e. the cell is not an empty black square)

- the column is a level that supports shuffling (i.e. audio1, audio2, ..., audio16)
- Once a shuffle is configured for a source/destination for a given level, you can remove the shuffle by selecting the source/destination and clicking the shuffle icon in the column header again to show the logical level selector. Then you can do one of the following:
- Deselect the preselected level so that there are no levels selected then click OK
- Select the same level as that of the column (i.e. the one that is mentioned in the title of the popup selector). For example, if shuffle is defined on audio1 column to audio3, then click on icon in audio1 column again, and select audio1 level.
- If a shuffle is defined for audioX, and the stream associated with the source/destination for that level **CHANGES**, then the shuffle remains (but it will now apply to the new stream).
- Example: Drop Cam1 on SDI. Configure shuffle on audio1 column. Drop Cam2 on audio1. See the shuffle icon remains. Click the garbage can to delete Cam2 from audio1. See the shuffle icon remains (because the stream inherited is now Cam1.
- If a shuffle is defined for audioX, and the stream associated with the source/destination for that level is **REMOVED** (i.e. the cell becomes a black square), the shuffle is deleted.
- Example: Drop Cam1 on SDI. Configure shuffle on audio1 column. Click the garbage can to delete Cam1 from SDI. See the audio1 cell is empty. Drop Cam2 on SDI (or SDI audio or audio1) and verify there is no shuffle icon for audio1.

#### **Batch update**

- If desired, you can select multiple sources/destinations (using Ctrl+click or select+click on rows) and then click the shuffle icon on a given column to define a shuffle for all selected sources/destinations simultaneously.
  - When click on the shuffle icon, the logical level selector will pre-select the shuffled source level if all selected sources/destinations had the same shuffled source.
  - If the selected sources/destinations had varying shuffled sources, the logical level selector will not be able to pre-select anything. Any selection at that point will update all selected sources/destinations.

#### Performing takes with logical sources/destinations that have embedded shuffles:

- Since embedded shuffles can be defined in both logical sources and destinations, it is possible to perform a take between a logical source and a logical destination that both have embedded shuffles. In such a case:
- Take should FAIL when both the source and destination have a shuffle defined to the same destination, but using different sources. For example: source shuffles A3
   > A1, and destination shuffles A4 -> A1.
  - Error: Invalid shuffle configuration defined in devices X and Y. Multiple sources shuffled to level audioZ.
- Take should PASS when both the source and destination have a shuffle defined to the same destination, and use the same sources. For example: source shuffles A3 -> A1, and destination shuffles A3 -> A1.
- If a shuffle refers to level that has no stream, then the take should FAIL with error "No path from sourceX to destY in current configuration."

- Example1: Create a logical source. Drop Cam1 stream on audio1. Add shuffle on audio1 to audio3. See that there is no stream in audio3 column. Try to take this logical source to Mon1. It should fail because the result should be that Cam1/A3 -> Mon1/A1, however there is no stream at Cam1/A3.
- Example2: Create a logical destination. Drop Mon1 stream on SDI. Add shuffle on audio1 to audio3. Create a logical source. Drop Cam1 on audio1. Take the logical source to logical destination. It should also fail because the destination is requesting audio3 from the source, but the source does not have a stream there.
- If the logical source defines a shuffle to a level (for example A3 -> A1) and that source is routed to a destination that does not have that destination level (A1), then the take should still complete successfully because it still performs the best take possible.
- Example: Create logical source, drop Cam1 on SDI, shuffle A3 -> A1. Create logical destination, drop Mon1 on video-ancillary level. When take source to destination, only video-ancillary level will be matched, and the shuffles will be ignored.
- [Ref. #PEG-8981] **External ID now utilized for physical and device control:** The NP0017 ID was deprecated with the release of GV Convergent 1.5.0. This allows you the flexibility to edit and re-index the external ID, but also warns you of the implications of this action.
- [Ref. #PEG-9020] **Changed row selection color on Logical Device Table:** The color had been too similar to the color in the cells. The new color is closer to a teal color to differentiate between the cell color and the row selection.
- [Ref. #PEG-9062] **DHCP leases for control panels are now set to not expire by default:** This is what happens when a panel is power cycled or freshly connected:
  - The panel, having forgotten its previous IP, sends out a DHCP\_REQUEST with its MAC address.
  - The GV Convergent server responds:
  - If itaddress), the GV Convergent server issues a new IP right away.
  - If the GV Convergent server does have a record of the MAC address because the GV Convergent server previously gave it an IP, the GV Convergent server refuses connection until the lease/MAC address combination is purged.
  - This can take as long as a 2 minutes.

## **Bugs Fixed**

- [Ref. #PEG-8448] Northbound Controller Status is made accurately to the GV Convergent: Found and fixed a problem where the cached labels in the GV Convergent database would be wrong after performing a re-index on the alias editor. Also, added De-bouncing before notifying clients of label changes.
- Some changes in GV Convergent will cause client connections to be closed to force a client to reconnect. The update in the client side might take some time based on their polling and how quickly they detect the loss of connection.
- [Ref. #PEG-8991] User-defined logical levels can be integrated with system defined logical levels: Compatibility is now available between the system defined logical levels and the user-created logical levels. The system defined logical levels have been reduced to a very basic set. This will allow you to only identify and set compatibility rules when absolutely necessary dependent on the necessities of their environment.

- [Ref. #PEG-8214] Unnecessary field for Master Controller removed from the Area Configurator: The Master Controller property was for future use and did not affect any use in the database. This property was removed from the System Controller Properties.
- [Ref. #PEG-8427] Short label or device name is now displayed on the logical level button for control panels: This addressed an issue where the longer, more descriptive, name was displayed on the logical level buttons of the control panels. This was usually truncated to the 8 character limit, and not useful to users.
- [Ref. #PEG-8760] Logical Level selector pop-up window is now independent of screen resolution: There was an issue where a low screen resolution prevented you from seeing the entirety of the pop-up window for selecting logical levels. This has been addressed in the code to allow users with lower screen resolution to view the entire pop-up.
- [Ref. #PEG-8794] When gateway communication is offline, joins and leaves will not occur: There was a race condition between the notification of the offline state and the actual offline state. When the race condition happened, the control port was set to offline before the monitoring thread detected that it was offline. When the monitoring saw the offline state it didn
- The fix added a new local variable that keeps the last state sent to the listeners, that way the listeners will always be notified when the control port goes offline.
- [Ref. #PEG-8826] **Time out value for NP0016 communication with the GV Node set to 500ms:** The original time out value was set to 200ms, but with the further processing from TR04 and 2110 work flows, GV Convergent has changed that default to 500ms to accommodate the processing of the response in GV Node.
- [Ref. #PEG-8879] **Tieline paths are now cleared when setting Transmitter stream to 0.0.0.0:** In the past to free the tieline path, you could enter 0.0.0.0 into the receiver multicast IP group IP. However, doing the same on the transmitter side did not free the tielines for the redundant path. This has been corrected in the code.
- [Ref. #PEG-8906] **NP0017 device-based status available at initialization:** Improvements were made to the code that addressed an issue where known status within GV Convergent was not being related to northbound controllers. This is no longer the case.
- [Ref. #PEG-8908] You must unlock a destination prior to protecting the same destination: You must now unlock a destination prior to protecting the same destination.
- [Ref. #PEG-8921] NP0016 IP command has the ability to push format change to GV Node: The new NP0016 IP implementation that allows GV Convergent to send commands to the GV Node on port 5195, includes the format type index. Based on what is in the field, the receiver can be changed to the logical level that relates to the correlating format type index.

This created an issue for 50Hz signal types, as GV Convergent had not yet implemented these as system defined logical levels. This shortcoming was addressed by sending the unknown format type index that directed the GV Node to not alter the current format of the receiver.

- [Ref. #PEG-8954] **Corrected issues with NP0017 Northbound retrieval of mnemonics commands:** The following problems were found and corrected with some of the NP0017 device based messages returned through the northbound interface:
  - The GetMnemonicsResponse have a byte count value higher than needed. This causes the message to be padded with hundreds of 0 value bytes.
  - The GetDeviceLevelsResponse 0x8000 3018 does not contain the correct value in its 0x0000 3018 request.
  - The GetDeviceLevelsResponse 0x8000 3018 does not contain any level data.
- [Ref. #PEG-8961] **External ID must be 1 or greater to work with NDAC:** There may an offset dependent on the northbound protocol used where external ID 1 in GV Convergent equals zero to the northbound controller. However, GV Convergent will have a limitation of 1 being the lowest external ID that you can set.

External ID of -1 may be set by GV Convergent if you enter a duplicate external ID against the advice of the client interface. The duplicated external ID will become -1 to be easily identified by the individual making configuration changes.

- [Ref. #PEG-8964] You can set a logical level to have no level: Once selecting a logical level on a stream or device, you could not deselect a defined logical level. This has been addressed in the code.
- [Ref. #PEG-9025] All levels take if appropriate level buttons not placed on the control panel: Prior to this improvement, if the level buttons placed on the panel were not correct for the logical devices selected, then the Take button would not become enabled, or high tally when selecting the logical devices. This addressed that issue by allowing you to perform an all levels take, that will process a take between the source and destination logical devices on all levels that match between the devices regardless of the level buttons defined on the panel.
- [Ref. #PEG-9028] Adjustments to the Logical Device Table for a more intuitive UI: Breakaway icon is displayed on the source/destination if at least 1 stream is a breakaway.
  - Shuffle icon is now displayed on the source/destination if at least 1 stream is shuffled. It is no longer displayed on individual cell.
  - Too long Source destination labels are now "..." in the middle of the label.
  - Port number is now only displayed in the dark blue box for non shuffle-able streams. This is to not confuse you when an audio stream set its shuffle level.
  - The breakaway icon indicates that a stream level has been overridden.
- [Ref. #PEG-9160] User-defined levels will be needed to create rules for compatibility: GV Convergent has simplified the logical levels that are assigned by default to the devices. The idea is the assumption that all of user signals are interchangeable within the topology. If this is not the case, then you will need to define logical levels and/or manage the compatibility rules of the logical levels to limit what source logical levels the destination can have routed to them. As an example, an SD signal made to be compatible with an HD logical level, to allow an SD signal to be routed to an HD destination.

### **Bugs Fixed**

- [Ref. #PEG-5101] Support of TICO signals: see TICO IPG-3901 support in GV Convergent, on page 66.
- [Ref. #PEG-7574] **Asynchronous message from GV Node improves on clean switch take times:** The GV Node driver in GV Convergent has been modified to communicate using the NP0016 streaming protocol when the GV Node has firmware version 2.2.0 or higher. If the logical destination being switched to is configured as GV Convergent will wait for the GV Node to report all IP streams to be locked before performing the last video switch in the chain. If a stream doesnwithin 2 seconds, the last video router will then be switched.

• [Ref. #PEG-8690] NP0016 driver polling frequency improved: The NP0016 driver has been updated to mimic the polling behavior of the NV9000.

For compact routers (UDP) the polling cycle still occurs every 1000 ms and is as follows:

- 1 Check if a take command needs to be resent.
- 2 Check if a lock/protect command needs to be resent.
- 3 Request output status(0x00000052) of the next 64 router outputs.
- 4 If supported, request the destination status change(0x00000053) for EACH of the configured levels.

For enterprise routers (TCP), the polling cycle has been changed from 500 ms to 300 ms and is as follows:

- 1 Send a 0x00005000 message to get the frame status.
- 2 Request output status(0x00000052) of the next 64 router outputs.
- 3 If supported, request the destination status change(0x00000053) for EACH of the configured levels.

Prior to these changes, each poll cycle would send in a single batch the (0x00000052) commands for all the outputs of all the levels of the router. This would generate a large burst of requests to the router.

• [Ref. #PEG-8781] **GV Node exposed streams are now configurable as a source and destination:** Prior to this fix, the output lane streams were only able to be exposed - with the sources displaying in the stream browser of the sources on the logical device table. Similar to that, the exposed streams of the receiver will display in the stream browser of the destination logical devices. This is no longer the case and the streams will display in the source and destination side to cover the use cases of Transmitter as a destination, and Receiver as a source.

• [Ref. #PEG-8898] Loopback accommodation for GV Node while using exposed streams: GV Convergent accommodates the requirement to not receive the same content that is transmitted from the same interface - this is referred to as "loopback." This feature was not working when exposing the streams on the transmitters and causing the GV Node receivers to join those streams. This has been corrected in version 1.4.1.

## **GV Convergent Version 1.4.0**

This release adds the following enhancement(s) and corrects the following issue(s).

### **New Features and Enhancements**

GV Convergent 1.4.0 adds the following new features and enhancements.

- [Ref. #PEG-6325] GV IP LDX Router Control support: GV Convergent now supports the ability to cause the LDX receivers to join send streams.
  - 1 Add a camera with a REST API Control port to your GV Convergent topology.
  - 2 Enter the IP Address of the LDX.
  - 3 Activate the topology for the camera to retrieve the information from the XCU and create its ports.
  - 4 There is one input port and one output port.
  - 5 Connect the camera to the network switch, via its physical connections.
  - 6 Use the automatically created logical devices to control the receivers. Alternatively, you can create the logical devices manually.
- [Ref. #PEG-7367] **Device properties for IPG-3901 have been updated:** GV Convergent device properties for the IPG-3901 have been updated to simply the control characteristics of GV Convergent in the topology.
- [Ref. #PEG-7434] Version 9.0 support for IPG-3901 4 audio receivers: The gateways for the IPG-3901 now offer up to four receivers to join AES-67 streams in a TR04 workflow. These act as tie lines, allowing you to join additional streams in order to retrieve audio channels for a breakaway to be embedded on the SDI output. Once the four receivers have been caused to join four streams, takes, requiring additional audio, will fail unless they can reuse an existing tie line or replace previously joined streams.

## • [Ref. #PEG-7584] Version 2.2 of the IPG-3901 can now operate in TR04 mode: GV Convergent supports the control of IPG-3901 version 2.2 operating in TR04 mode with video and audio streams to or from SDI ports. The IPG-3901 is now a virtual device that can be added to a topology. It replaces the Gateway virtual device. This migration is automatic during upgrade.

**Known issue**: The embedders of the SDI output on the IPG-3901 are always on and can only be disabled completely during configuration in iControl. In the next release of IPG-3901 (v2.3), you will be able to configure a source without audio, or with free source audio, on the audio logical levels to disable the embedders.

• [Ref. #PEG-6087] **Support of** The GV Convergent IPG-3901 driver was updated to support the loopback functionality. You can now route an SDI input of an IPG-3901 from GV Convergent to an SDI output on the same IPG.

• [Ref. #PEG-8444] **Safety added for re-index button on Alias Editor:** If you hit the **Re-Index** button after the External ID column is shown, you are asked for confirmation via a toaster pop-up. You cannot press the Re-index button again until you have confirmed your intent.

If you enter a conflict in the External ID column, the old error message is now displayed in a toaster pop-up, instead of the dialog. The table cannot be changed until you have confirmed your intent.

If you attempt to show the External ID column, and do not have the required security permissions, a warning is displayed as a toaster, instead of a dialog, pop-up.

#### **Bugs Fixed**

• [Ref. #PEG-6303] **Two automatic logical sources are created for Redundant Generic IP devices:** Only one logical device will be automatically created for a redundant (2022-7) device.

A correction was made in the code to prevent the automatic creation of a logical device for each port of a redundant-defined device in a 2022-7 architecture. One logical device is now automatically created and both streams are displayed in the stream browser. If you include one of these streams in a logical device, both streams will switch when the logical device is switched.

- [Ref. #PEG-7265] **Replaced outdated label "Source Table" with "Logical Device Table":** The source table stage, in the GV Convergent, was replaced with the Logical Device Table, where you can select between logical sources and destinations.
- [Ref. #PEG-7307] DCNM hosts are not named correctly because GV Convergent does not support bidirectional ports: The DCNM host represents a physical Ethernet interface.

GV Convergent does not have the concept of a host.

For example, in GV Convergent, you could define multiple input physical interfaces, of type IP, using the same IP address and then define other output physical interfaces, of type IP, using different names.

This creates issues in the DCNM driver because the DCNM API assumes that a host can have only one IP address and only one name.

Workaround:

- Use the same IP address for the input port and output port that share the same number on a device.
- Distinguish between the ports labels using "In" and "Out;" for example, Eth1Out and Eth1In.
- [Ref. #PEG-7694] **Panel Status no longer stays offline after the configuration is restored.** This bug was addressed within the code to properly update the status of the panel after a system restoration.
- [Ref. #PEG-7766] The DCNM system status is no longer displayed incorrectly as Online: The behavior is as follows:

Case 1: We disconnect ETH (uncheck "connected" in ESX Host).

Case 2: We power off the VM completely.

In both cases, the DCNM information disappears from the System Status page (Active, Standby and HA Status), and the actual status changes to red after a few seconds.

- [Ref. #PEG-8161] **Operations added to a salvo are displayed in the order they were selected:** Previously, operations were not displayed in the correct order.
- [Ref. #PEG-8283] **Streams were not updated correctly on the IPG in aggregation mode:** Device Properties on the IPG-3901 are now updated properly when you switch between aggregation and redundant mode.
- [Ref. #PEG-8481] An invalid IP conflict message was received when RX and TX IPGs had the same multicast IP: The invalid IP conflict message is no longer received when an IPGdata model.
- [Ref. #PEG-8485] Synchronization of XPTs now occurs between GV Convergent controllers in a reasonable amount of time: Takes occurring in less than 30 seconds after a failover were not synchronizing between controllers in a previous build of the code. This has been addressed in the redundancy mode.
- [Ref. #PEG-8578] The NP0016 was sending unnecessary responses to clients on a crosspoint change: The sending of 0x80000050 messages was removed for crosspoint changes, which were not requested by the NDAC NP0016 client.
- [Ref. #PEG-8604] The Force Active button now appears 30 seconds after a failover: The Force Active button appeared 2-3 seconds after a failover even if the system was not ready. This has been addressed in the code.
- [Ref. #PEG-8671] **Devices were missing in the status page with a specific DB following a force active:** This issue was addressed in the code and the missing information on the status page will now display.
- [Ref. #PEG-8710]**The Video + ANC button is now required for TR04 routing:** In TR04 mode of operation, the ancillary is embedded in the video and you cannot route the ancillary data separately. GV Convergent is still monitoring the ancillary and looking to route that stream as part of our pathfinding. This created the need for a Video + Ancillary level button. This level button can be used in conjunction with the audio (AES-67) logical level button(s) for routing TR04 signals and performing a breakaway.
- [Ref. #PEG-8754] **Takes are causing DCNM host policies to be removed incorrectly:** Previously, when a take changed a receive stream IP address from an old value to a new value, the DCNM driver (and NMOS driver) interpreted that as a change in send stream IP address. That triggers the removal of flow policies associated with the old IP address. This issue was addressed in the code, and no longer occurs.
- [Ref. #PEG-8757] Database migration from 1.3.0 to 1.4.0.
  - 1 When migration is complete, the GV Node"unknown," until you deactivate and reactivate the topology.
  - 2 The logical levels of the devices connected to the GV Node may need to be changed to be consistent and compatible.
- [Ref. #PEG-8774] **Pegasus service now starts after a version 1.3.0 database is restored:** Restoring a database backup from 1.3.x takes longer than restoring one from the current version (1.4.0). In fact, it could take up to seven minutes.

## **GV** Convergent Version 1.3.1

This release adds the following enhancement(s) and corrects the following issue(s).

**New Features and Enhancements** 

GV Convergent 1.3.1 adds the following enhancements:

- [Ref. #PEG-8594] **GV Convergent restarts the active controller on failover:** When you click the Force Active button on the standby controller, GV Convergent restarts the currently active controller. This allows for a cleaner transfer of the services to the newly active controller. This also serves the purpose of severing the synchronization between controllers until the inactive system is back online, a very short time later.
- [Ref. #PEG-8453] Active and standby states are redefined in the GV Convergent Controller redundancy model: This ensures that the controller and database are valid and can provide the required factors to set the active or standby state on a GV Convergent controller at startup. Previously, the cluster could be in an inconsistent state when network interruptions occurred. For example, the standby controller may not have fully started or data may not have been synced between the active and standby controllers.

## **Bugs Fixed**

- [Ref. #PEG-8465] **Invalid configuration files can no longer be restored:** Functionality to ensure that invalid configuration files cannot be uploaded and restored has been migrated to the new GV Convergent Admin.
- [Ref. #PEG-8583] **GV Nodes migrated from unreleased versions of GV Convergent must be manually deleted:** If you added GV Nodes to a topology created prior to GV Convergent 1.3.0 Build 810, you need to perform the following fix. Open the topology in the GV Convergent > Topology Configurator. Delete the GV Nodes. Add new GV Nodes to the topology and redo the physical connection.
- [Ref. #PEG-8440] **Undo functionality is now completely removed.** Previously, you could use the keyboard shortcut Ctrl + Z to reverse an action, even though the Undo button was removed. This is no longer possible.
- [Ref. #PEG-8424] System Controllers can now be removed from the Area Configurator stage task in all deployments: A unique bug, logged by a user who was unable to remove a system controller in the Area Configurator, was fixed. The user's database had been corrupted due to redundancy testing.
- [Ref. #PEG-8380] Incorrect warning of IP address conflict is no longer displayed: Previously, a warning message was displayed incorrectly because the IP address validation did not detect the last Ethernet port pair as the same port. This has been resolved.
- [Ref. #PEG-8379] **Disabled streams on the IPG**Based on the configuration of an IPG, certain streams will be disabled, but will maintain their multicast group IP. The process that warns you of duplicate IPduplicates. They should be ignored due to the fact that those streams are disabled.

• [Ref. #PEG-7768] Some host policies, created from the DCNM web interface were not removed when GV Convergent was in exclusive mode: Previously, the GV Convergent cache that contained the DCNM host policies was not cleared. The cache is updated before the synchronization with the DCNM host policies and after a host policy delete.

On the Cisco DCNM, the host ID is not always reliable between queries.

Therefore, in case the host policy ID has changed since the last query was executed, GV Convergent verifies that the last and correct host ID is present before executing the delete query.

- [Ref. #PEG-8450] **Buttons on panels are no longer flashing:** This was reported during some on-site testing, but a fix was introduced to resolve the issue. The panel buttons should no longer flash on fail over of the GV Convergent servers.
- [Ref. #PEG-8484] Initial third party updates slow down takes in the first minutes after failover: The fix was to consider the port direction while doing the initialization of all ports and streams, only enabling the streams and ports of the proper direction. It no longer takes an excessive amount of time before 3rd party takes are allowed after failover.
- [Ref. #PEG-8473] **IPG3901 port labels are now updated dynamically in GV Convergent:** At one point when you modified the port label of a port on an IPG-3901 card, the changes are were not being dynamically reflected in GV Convergent. This has been addressed in the code.

## **Known Issues and Limitations**

The following is a list of known issues and limitations associated with GV Convergent. The star ( $\star$ ) symbol indicates a new issue in GV Convergent version 3.4.0.

- [Ref. #PEG-3498] A refresh of the Router UI may be needed to reflect changes in the Alias table: If you update the Aliases while the Router Control UI stage is open in the GV Convergent, you may need to reopen the Router Control UI to reflect those changes.
- [Ref. #PEG-4269] Adding logical devices while panel configurator is open may not display the devices sorted correctly: when adding sources and destinations in a Topology while the Panel Configurator is open and the Sources or Destinations view is exposed, the created sources or destinations adds them into an unsorted order in the Panel Configurator view. Also applies to salvos and other items. *Workaround:* Closing and reopening the stage in GV Convergent will address the sorting issue.
- [Ref. #PEG-6457] **"ERROR GUI panel not found" is displayed when launching client:** if this message is displayed, close and reopen the client.
- [Ref. #PEG-6646] No keystroke duplicate warning is displayed when setting the same keystroke more than once: within the Category Configurator Stage, if you set the keystrokes of more than one device to the same keystroke assignment, they can create an issue where the desired device may not be selected from a panel whilst using the keystroke selection option from a category button.

*Workaround:* Take care to provide unique keystroke selection for each device.

• [Ref. #PEG-6749] GV Convergent does not automatically reconnect when changing the management IP address

*Workaround:* If this occurs, close and relaunch the client. Then, log in with the new IP address.

- [Ref. #PEG-6958] **Physical Connections Builder may not reflect disconnected ports:** if you disconnect physical connections for the Connected tab in the physical connections editor, on the topology configurator stage, the now disconnected ports, may not display in the builder section. If this occurs, you may need to click off the physical connection and then back onto it to see the ports available for connection.
- [Ref. #PEG-7159] **Phantom buttons on hardware panels can be cleared by changing pages:** Changing the location of a level button on an active panel can create a button with text, but no color. The label of the old button may remain. Changing the page, or opening a list page, to re-legend this button will refresh the button. This only affects the panels with the LED buttons.
- [Ref. #PEG-7283] The keystroke does not work when the suffix is composed of both a letter and a number

*Workaround:* If this occurs, either use only numbers or use only a single letter for the suffix/keystroke to select devices within a category.

• [Ref. #PEG-7815] **Takes may fail on redundant IP sources with inverted connections:** when using a redundant (2022-7) network, if you connect the first output port to the B network and the redundant port to the A network (invert the connection), you might see a take failure if the connection on the other side of the network fabric is not inverted.

Similarly, having a non redundant IP device connected only to A network will allow us to do a take, but having it connected only to B network will not.

Connect first port to the A network and redundant port to B network to resolve this.

- [Ref. #PEG-7830] Black screen appears when you open the Panel Configurator stage *Workaround:* if you receive the black screen when opening or selecting the Topology Configurator stage, close and reopen the stage.
- [Ref. #PEG-7922] Software panel configuration may not reflect panel behavior change when the topology is not active: if the GV Convergent topology is not active, and you switch the panel behavior to a different panel, and then activate it, the changes will not be reflected on soft panels.

However, if the topology is active, you can switch the panel behavior and it will do the switch on the fly as expected.

- [Ref. #PEG-8009] **Tie lines view is not updated dynamically when a short name is changed:** when you change the short name of a device, the Path Management (Tie lines view) is not dynamically updated. *Workaround:* Click the Refresh button.
- [Ref. #PEG-8018] Ports appearing in "Other" physical connections table are not updated dynamically after changes are made to the device: when changing the device short name or device count for the corresponding ports appearing in the "Other" table, the table is not dynamically updated. *Workaround*: If this occurs, deselect/select the link.
- [Ref. #PEG-8096] Category Configurator is very slow to assign and delete large numbers of sources and destinations: if you are experiencing a delay, then as soon as you see the sources are deleted from the screen, close GV Convergent and reopen it. This way you skip the unnecessary delays.

As for the creation of the category, you can do the same thing. Close GV Convergent after a while and reopen it.

• [Ref. #PEG-8097] Logs fill with stack traces when an external controller is configured with an incorrect matrix ID

*Workaround:* if this occurs, fix the matrix ID or stop the external control system from accessing NDAC, or change log level for this module. This may well hide other important errors in this same module.

- [Ref. #PEG-8235] **Deleting devices by decreasing the device count is faster when all other GV Convergent stage tasks are closed**: if the device count is changed when only the Topology Configurator stage task is open, the deletion is much faster. As soon as you open the Router Control or Path Manager stage task, it starts to slow down.
- [Ref. #PEG-8251] Google Chrome is the supported browser for operating the GV Convergent Admin Web Stage: issues have been found with Internet Explorer 11 and the upgrade feature from the GV Convergent Admin page. We recommend using the Google Chrome web browser.

- [Ref. #PEG-8255] **System Status page displaying routers that have been deleted:** after deleting dummy routers on the loaded topology, the System Status UI was still showing the statuses of the deleted routers without their labels. *Workaround:* Close/reopen the System Status UI.
- [Ref. #PEG-8284] The Alias Editor are not updated dynamically when physical connections are deleted in the topology: if the Alias Editor stage task is open and you sever physical connections in the Topology Configurator task, switching back to the Alias Editor may not reflect the deletion. *Workaround*: If this occurs, click on the refresh button on the Alias Editor.
- [Ref. #PEG-8317] The GV Convergent Admin Backup and Restore does not display the correct host name when the host name has a hyphen in it: it is not recommended to use a hyphen in the host name.
- [Ref. #PEG-8328] **Take should fail with an incorrect physical level configured on a router:** if you have configured a router, but has the incorrect physical level value, GV Convergent attempts to perform the take. If the physical level does not exist on the router, no actual XPTs are switched.
- [Ref. #PEG-8332] Router Control UI not updated after multi-select take on NV9654 hardware panel

Workaround: If this occurs, then close and reopen the GV Convergent application.

• [Ref. #PEG-8449] Changing the standby server IP without breaking the cluster is not possible

*Workaround:* If you have to change the IP address of the standby server in a redundant cluster, then it is necessary to break the cluster. To do so, set the number of controllers in the Area Configurator to 1 and press enter. Then, change the number of controllers back to 2 and enter a new IP address for Controller 2 in the Properties Editor.

• [Ref. #PEG-8469] The virtual IP address cannot be the same as the IP address of either the active or standby controller: also, you cannot use the same IP for both the active and standby controllers. If this is the case, then you will need to edit one, or both controller IP addresses in the area configurator.

*Workaround:* If the virtual IP address is the same as the IP address of a controller, or if the both controllers have the same IP address, open the GV Convergent > Area Configurator > Property Editor and edit the IP address of one controller or both controllers.

- [Ref. #PEG-8520] Hosts/flow policies are not being re-created in DCNM after a DCNM HA failover. If the active DCNM in a HA availability DCNM configuration goes offline, DCNM will fail over to the standby DCNM, but it will not have the hosts/flow policies that were currently available on the previously active DCNM. To fix this issue we have to deactivate and activate the topology one more time.
- [Ref. # PEG-8542] **A Bad Device Graph Is Loaded After A Switch Of Area:** the original area may be displayed when you create a new topology, make it active, and then create a new area. If this occurs, then click on the new area to display it.
- [Ref. #PEG-8585] Ethernet NIC ports on GV Convergent Admin > Network Settings are listed in reverse order: currently, only the em1 interface is enabled on startup of GV Convergent. When you edit the configuration of the interfaces in the web stage, it is important to note that, from the rear, the right most network port actually relates to p6p1. These interfaces also need to be manually enabled using the command, "ifconfig [interface] up" (i.e. ifconfig em2 up) through SSH to GV Convergent, or on the Linux command line interface.

- [Ref. #PEG-8602] **The last take operation added to a salvo can appear incorrectly at the beginning:** when you add take operations to a salvo, the last take operation added should appear at the bottom of the list. However, it appears at the beginning of the list. If this occurs, then delete the unsorted operation and add it again.
- [Ref. #PEG-8708] **Underscores are ignored in topology naming:** it is recommended that you replace underscores with another character when naming the GV Convergent topology.
- [Ref. # PEG-8782] **Refresh issue in the logical device table while exposing stream:** while exposing streams and having the logical device table opened, the logical device table can become out of sync when you navigate between the Source and Destination tab of the table. Sometimes the stream will not appear immediately, or sometimes they will not update after changes in the topology.


Workaround: Refreshing, or reopening the table, can fix this issue.

• [Ref. #PEG-8820]**The Web stage login button is not enabled when using remembered login and password:** the web-stage login button is not enabled when you select the remembered user and password.

*Workaround*: If this occurs, press the enter key in one of the two fields, or press the tab key in the user field.

- [Ref. #PEG-8834] Checking Automatic Sources on Outputs does not assign the streams on some Logical Sources: if the logical device table is open when editing the device properties on the topology, and you choose to automatically create sources on Outputs, then you may need to press the refresh (recycle) icon to refresh the devices.
- [Ref. #PEG-8840] Logical Device Table streams are still shown after deleting a physical connection link: deleting a physical connection link on the active topology should remove the logical devices that may have been created for a device. However, if the devices are still seen on the logical device table, then pressing the refresh (recycle) icon on the logical device table, will refresh the table.

• [Ref. #PEG-8859] **Redundant port device property displayed with improper format:** after editing the device property # Output connectors to 2 and setting the Redundant port on Out 1, the redundant port was shown as follows. The workaround is to deselect/re-select the Out 1 port tab.



- [Ref. #PEG-8860] Takes to an exposed destination will fail due to missing logical level assignment: if you expose streams at a port of a router, but that port does not have a defined logical level, then placing that stream in a logical device and performing a take on/to that device will fail. You must manually configure the logical level on the device properties in the topology.
- [Ref. #PEG-8871] Using Exposed Streams May Create Inaccuracies in Path Manager: utilizing the exposed streams functionality in the GV Convergent topology, may create instances where the path manager will not show complete status.
- [Ref. #PEG-8882] Multicast IP group address changes made to XCU are not applied to GV Convergent: in the case that you edit the multicast group IP address in the XCU for GV Cameras, there is a chance that these changes will not propagate to the GV Convergent Topology. The workaround is to deactivate and reactivate the GV Convergent Topology.
- [Ref. #PEG-8962] **External IDcontroller:** when the assigns a duplicate external ID in the Alias Editor, the other device with the duplicate external ID, will receive an external ID of -1 to identify an issue. External IDsources or destinations, will not report status to the northbound controller.
- [Ref. #PEG-9163] Entering characters in all caps into the Alias editor requires a workaround:
  - 1 Click on a cell
  - 2 Press Enter first
  - 3 Start entering the characters in all caps
- [Ref. #PEG-9174] **Topology name limited to 256 characters:** creating a topology in GV Convergent with a name longer than 256 characters causes UI issues. *Workaround:* You must limit the name to less than 256 characters.

- [Ref. #PEG-9176] Clicking on another Physical Connections link while making connections on another link will interrupt process: while in the process of connecting the physical connections of a link within the topology, if you click on another link, all of the connections may not be processed for the former link. You will need to click on the former link and process the remaining connections.
- [Ref. #PEG-9180] **Keystroke Creator option from separator does not work properly in the Category Configuration Stage:** if the suffixes of your logical device names have less than 2 characters (1, 2, ...), then the automatic keystroke editor may not automatically assign the correct keystroke when using the "From Separator" option.
- [Ref. #PEG-9373] Router Control UI may not update if one of shared control servers is rebooted during takes: when 2 servers are controlling the same router and one of the servers is rebooted while takes are being performed on the client connected to the other server, the Router Control UI of the clients connected to the rebooted server may not refresh Router Control UI when the server comes back. *Workaround:* reopen another Router Control UI task.
- [Ref. #PEG-9389] **Deleting an NMOS device may leave a ghost device in System Status stage:** when we add an NMOS device to an active topology we show the status of that device in the system status page. When we delete the device the system status page does not refresh properly and we end up with an empty slot showing "Unknown". *Workaround:* Closing and reopening the System Status stage will address this issue.
- [Ref. #PEG-9435] **Discovered Devices control ports may stay online when you deactivate a topology:** if a discovered device is added to an active topology, its control port will come online. If you deactivate the topology then the control port remains online when it should go offline. Reactivating and deactivating the topology again gets the control port to go offline.
- [Ref. #PEG-9439] You may not be notified when timeout has been reached is a large configuration: currently, with the default timeout and polling method for the restoration of the database through the Web Interface, larger configurations may not completely be restored and may revert to their previous database without notifying you.

The default values must be edited to accommodate larger configurations (>2GB). The current default values from /var/lib/tomcat7/webapps/admin/WEB-INF/classes/admin.properties:

#Timeout values for backup and restore.

# serverStatusRetries: Number of retries when checking for server readiness before giving up.

# serverStatusInterval: Interval in milliseconds between server readiness check retries.

# Total timeout for service to restart after a backup or restore is serverStatusRetries \* serverStatusInterval

# When restoring a backup from an older version, multiply the timeout time by the factor migrationMultiplier.

serverStatusRetries=36

serverStatusInterval=5000

migrationMultiplier=5

This currently allows only 3 minutes to restore a configuration, and up to 15 minutes for legacy configurations. Changing the serverStatusRetries to 60 would allow up to 5 minutes and 25 minutes, respectively. The issue is that if there is a problem with the

database, GV Convergent will wait the total of this timeout prior to giving up and reverting.

- [Ref. #PEG-9456] Streams may no longer be completely mapped after changing the GV Node Mode: when using exposed streams on GV Nodes and changing the card mode from TR03 to TR04 for example, the stream assigned in the ANC cell is not removed. Since TR04 does not have ANC, we should remove the streams in that cell since the stream no longer exists in the system. Workaround: manually remove the stream.
- [Ref. #PEG-9508] **Do not use loopback IP in the controller properties:** using the loopback IP address for the system controller in the controller properties of the Area Configurator will cause a loop of restarts, as the controller attempts to create a cluster with itself. Utilize the physical IP of the system controllers.
- [Ref. #PEG-9529] Adding a destination to a virtual XPT when topology is inactive will not route virtual source to the destination: part of the GV Convergent implementation of Virtual XPTs is the freedom to not require you to manually create a salvo to initialize the virtual source to real destination path. This is accomplished when a real logical destination is added to a virtual XPT. However, when the GV Convergent topology is not active, this will not occur. You would then be required to route the virtual source to that real logical destination once the topology is active. *Workaround:* only add real logical destinations to the virtual XPT when the topology is active.
- [Ref. #PEG-9583] Creating a duplicate panel configuration may not display that panel in the configurator: when creating a panel configuration by duplicating an existing configuration, then it may be necessary to open the newly created panel, as it may not be displayed upon creation.
- [Ref. #PEG-9587] **Discovered Devices properties may be overwritten on reactivation of GV Convergent:** the unaffected attributes are logical level, # input connectors, # output connectors, # Streams per input, # Streams per output, automatic Destinations on Inputs, Automatic Sources on Inputs. All other fields will be overwritten on reactivation of the GV Convergent topology.
- [Ref. #PEG-9600] Clearing a database via ssh while the GV Convergent is connected may present an issue with editing configuration: when the clearing the database while the client is connected, the area and topology will not be editable. You will need to close and reopen the client and create a new topology.
- [Ref. #PEG-9762] **Unchecking exposed streams may affect pathfinding:** when third party changes are processed, GV Convergent figures out the list of sources/destinations which go through each tieline that is affected by the change, and then recomputes the tallies. When finding the sources/destinations, we only look at streams which are exposed. Therefore, if a stream has logical sources/destinations assigned to it, but is not exposed, we should be busy.

This situation can happen in the following scenarios:

- You add an edge device to the topology (for example, a camera or a monitor) and de-select the "Exposed Streams" property.
- You select the "Automatic Source/Destination" property, without selecting the "Exposed Streams" property.

Workaround: always leave the "Exposed Streams" check box checked.

- [Ref. #PEG-9763] Newly created logical device is not highlighted in the Logical Device Table: when you manually create a logical source or destination device in the logical device table, it is currently not highlighted and you may be required to scroll to the device.
- [Ref. #PEG-9765] Severing many links at once can cause the responsiveness of the user interface to slow down: in Topology Configurator, when cutting links with many physical connections, the user interface becomes unresponsive while the task is being executed.

Workaround: cut fewer links at a time.

- [Ref. #PEG-9893] Changing the mode of a K-Frame from 2022-6 to 2110 may cause extra ports to display in Client: changing the K-Frame mode of operation in the Switcher Menu application from 2022-6 to 2110 may cause additional ports to display in the GV Convergent topology, under the device properties for the Production Switcher. This issue occurred 1 out of 3 times during testing. *Workaround:* close and reopen the Topology Manager stage in the GV Convergent.
- [Ref. #PEG-9935] **Manually assigned keystrokes in the Category editor may not work on a panel:** Once you have manually added keystrokes to the devices within a category (rather than using the automatically add feature), this may cause these devices to not be selected with keystrokes on a panel. Pressing the category jumps to the keystroke page, but the keystrokes do not light up to indicate what keystrokes are available. *Workaround:* use automatically generated keystrokes.
- [Ref. #PEG-9943] Taking a backup/snapshot while performing large operations may corrupt database: deleting or creating large numbers of devices, physical connections, and then taking a backup while this is still taking place in the background can be hazardous to the health of the database. Monitoring the database activity via the SSH logging, or the resource usage on the System Status page prior to taking the backup/snapshot should allow you to avoid this issue.
- [Ref. #PEG-9950] You may be unable to add any destinations to a virtual destination once they have attempted to add incompatible destinations: as the virtual XPTs take on the characteristic logical levels of the actual destinations that are associated to the virtual XPT, or the virtual source is routed to; attempting to associate a real destination, that does not have logical levels compatible with the other destinations already associated to a virtual XPT, to said virtual XPT may create a situation where you can no longer associate any compatible logical destinations.

*Workaround:* You must delete the virtual XPT and then only associate compatible logical destinations after recreating the virtual XPT.

• [Ref. #PEG-9955] **Deleting a salvo when that salvo is assigned to a panel configuration may cause the panel to freeze:** deleting a salvo when the salvo is on a panel configuration may cause the panel to freeze if you attempt to execute said salvo on the panel.

*Workaround*: remove the salvo button on the panel in Panel Configurator, or recreate the salvo button on the panel.

• [Ref. #PEG-9965] Logical Device Table Filter is missing some values: if you open the logical device table and have not scrolled through the devices, and then try to use the filter, some of the devices that should be displayed when using the filter may not be shown. If you encounters this, you need to scroll down through all of the devices prior to using the filter.

• [Ref. #PEG-9971] **Exposing streams on a router may not properly reserve the bandwidth:** whilst using the exposing streams feature on GV Convergent, you are essentially removing the exposed streams from the tieline pool to create a source/destination at the port stream. Typically this would utilize bandwidth and that used bandwidth would be displayed on the Path Manager Stage. When exposing streams of the port streams connecting two routers, the bandwidth usage may not be displayed properly in path manager.

Workaround: reactivate the topology to properly display the bandwidth.

- [Ref. #PEG-10064] You must not sever the link between the Area and System Controller in Area Configurator: severing the existing link between the System Controller and the Default area may create a situation where the configuration does not become active after a restart. If this occurs, you may need to load a backup configuration to restore activity.
- [Ref. #PEG-10218] **Discovered devices may not display secondary device name:** if the secondary device name is not displayed in the discovered devices pane, then it may be necessary to reopen the Topology Configurator stage.
- [Ref. #PEG-10251] An alias may not be applied dynamically to GPIO editor: in the GPIO editor, if you select an alias for sources and destinations, you can enter the alias or system defined name for the destination and the editor logic can accommodate this. If you type in the system defined name for the source with the alias selected, the logic does not accommodate this. You will need to take the following steps:
  - 4 In the GPIO stage task, Select None for the Source Alias.
  - 5 Delete the GPI configuration.
  - 6 Select Route a source to a destination.
  - 7 In the source text field, enter the source name, not the alias.
  - 8 In the destination text field, enter the destination name, not the alias.
  - 9 Validate the rule.
  - 10 In GPIO stage task, Select Alias for Source.
  - 11 Now you will the see alias name for the source.
  - 12 Validate the rule.
- [Ref. #PEG-10388] DDS discovery devices added to the topology while activated do not appear in the System Status task: DDS discovery devices added to the topology while activated do not appear in the System Status Page, unless you de-activate and then activate the topology.

Workaround: Close and then re-open the System Status task.

• [Ref. #PEG-10466] **GV Convergent Cluster cannot be created if a DNS server is configured but is not reachable:** If a DNS server is configured on a pair of GV Convergent servers and the DNS server is not reachable (as they cannot be pinged), GV Convergent will be unable to create a cluster when creating the cluster configuration via the Area Configurator. The result is both servers to come back as master and kick each other out of the network in a loop.

Workaround: Remove the bad DNS entries and restart GV Convergent on both servers.

• [Ref. #PEG-10492] **Unable to break the link between a router and a monitor**: Sometimes you may encounter an issue where they will not be able to disconnect the link between an SDI router and a monitor, using the cutting tool after disconnecting the physical connection. The link gets stuck.

Workaround: Close and re-open the Topology Configurator stage.

- [Ref. #PEG-10501] Failed to find redundant path error when doing breakaway on IQUCP that is not set in redundancy mode: When doing audio breakaway or video breakaway using IQUCP cards that is not set in redundancy mode, the logs show "Failed to find redundant path" errors and the panel flashes red even though the breakaway is successful.
- [Ref. #PEG-10589] Changing source or destination short name is not reflected in the Category Configurator and Panel Configurator: changing source or destination short name is not reflected in Category Configurator and Panel Configurator. *Workaround:* Close and then re-open either the Category Configurator or Panel Configurator stages.
- [Ref. #PEG-10590] Virtual XPTS in Router Control UI is empty when removing a destination from Virtual XPT: if you have one Virtual XPT with 4 destinations configured in Logical Device Table, you see 4 destinations in the Virtual XPTS Area in the router control UI. If you remove one of the destinations from the Virtual XPT configured in Logical Device Table, all destinations in the Virtual XPT Area in the router control UI will be removed. *Workaround*: Deselect and select again the Virtual XPT destination in Router Control UI.
- [Ref. #PEG-10593] **Third party equipment doesnthat have no logical level**: when 3rd party equipment updates tielines and tallies, and the streams that are used for the logical source/destination have no logical level, then tallies and tielines will be cleared. *Workaround*: Set a logical level on the stream.
- [Ref. #PEG-10624] Third party notification broken when a GV Convergent server controls another GV Convergent server using NP17: Third party notifications may not work when a GV Convergent server is controlling another GV Convergent server using NP0017. *Workaround:* Deactivate and then activate the topology.
- [Ref. #PEG-10642] Changing connector type does not change stream type anymore: The stream type (e.g. SDI stream, IP stream) created for a device is based on the connector type (for example, SDI, or IP). However, if we change the connector type, the stream type does not change accordingly. *Workaround:* Set the stream count to 0 and back to itstreams to be deleted and recreated, now with the correct type.
- [Ref. #PEG-10737] Virtual XPTS Destinations selection not sorted properly: in the Virtual XPTS tab, the real destinations as part of the virtual destination are not sorted properly.
- [Ref. #PEG-10808] Audio Live path discrimination does not work if there are factory levels on one or more ports: The path finding will not use the specific ports with custom levels to convert the signal and instead will use any port that matches the required channel count.
- [Ref. #PEG-10842] IQUCP cards connection status off-line if the eth2 configuration is blank: The IQUCP card's connection status is shown off-line if the eth2's configuration is left blank.

Workaround: Configure eth2 with a valid IP Address and restart the card.

• [Ref. #PEG-10873] Missing tables in database when creating a cluster with a clean database: Creating a cluster from a GV Convergent server that has a clean GV Convergent database could trigger issues with the control port of the devices added in the topology.

*Workaround*: Restart the GV Convergent server before building a cluster with another controller OR failover right after creating the cluster.

- [Ref. #PEG-10874] **GV Convergent controllers switched in the System status page (first controller shown on the second column):** For GV Convergent, this issue could occur if the user decides to restore a backup from Controller-2 to Controller-1. *Workaround:* With both servers in a standalone mode, check each servercontroller columns. Do this by opening a GV Convergent for each server and re-creating the cluster from the server with the correct ID. See *Configuring a Controller Group* in the GV Convergent User's Manual.
- [Ref. #PEG-10883] **Discovered device stays on-line the first time the topology is disabled:** For GV Convergent, a discovered device stays on-line the first time a topology is disabled. The control port status is accurate whether the GV Convergent topology is on-line or off-line. This has no effect on the GV Convergent system.
- [Ref. #PEG-10958] NDAC: NP0017 port-based commands do not work properly if there are gaps in the external IDs: For GV Convergent, if there are gaps in the external IDs of the logical sources or destinations, the NDAC NP0017 port-based commands do not work properly. If the external Ids are sequential, the commands all work properly.

There are checks made which expect that the provided port IDs to be lower than the amount of sources/destinations. This is not true when there are gaps in the external id assignments.

*Workaround:* Use the NP0017 device-based commands, where gaps are supported properly.

• [Ref. #PEG-10976] GPIO rules are validated and saved without using the check box if the user switches to another rule: GPIO rules are validated and saved without using the check box if the user switches to another rule.

Workaround: Do not change to another rule if the current rule is not already validated.

• [Ref. #PEG-10977] Adding or updating Aliases is not reflected in an open "Router Control" tab: Adding or updating Aliases is not reflected in an open "Router Control" tab.

Workaround: Close and re-open the "Router Control" tab.

- [Ref. #PEG-10981] GPIO Takes executed once the GPI rule is activated: For a new rule, if the rule is not activated and the user switches the GPI input from either On-to-Off or Off-to-On, there will be no take executed. However, if the user activates the rule, then Takes related to the last transition are executed.
- [Ref. #PEG-10983] Source/Destination short label updates not reflected in open "Category Configurator" and "Panel Configurator" tabs: When the short label of a device is changed using the Topology Configurator, the labels are not automatically updated in the "Panel Configurator" or "Category Configurator" tabs, if they are already open.

Workaround: Close and re-open the respective tab to see updated labels.

• [Ref. #PEG-10984] **GPIO - Rule is not executed when it is created during an activated topology with a new database:** GPIO rules are not executed when starting a new topology with a new database.

*Workaround:* To execute those GPIO rules, deactivate the topology and then re-activate it.

- [Ref. #PEG-11182] **NMOS senders/receivers from the same port should all be redundant or all non-redundant:** Sender/Receiver streams from the same port should all be redundant or all non-redundant, otherwise pathfinding issues may occur. For NMOS senders/receivers, the interface\_binding property should have the same interfaces for all streams that are part of the same device/node. *Workaround:* Set NMOS streams to be all either redundant or not redundant as a source/destination is either redundant or not but not a mix of both.
- [Ref. #UCCM-2471] **Bulk routing panel blocked when no custom filter available:** If no custom filter is created and you select the Delete filter or Edit filter options, the bulk routing panel will get blocked with an empty pop-up in the middle of the screen. *Workaround:* Close and re-open the panel.
- [Ref. #PEG-11424] **Opening and closing GV Convergent causes increasing memory usage on server:** When using the GV Convergent for an extended period of time (weeks, months) and especially when closing and re-opening stage tasks, it was observed that memory usage on the server would gradually increase.

In order to free up that increased memory usage, close the client completely and launch it again, this will free up the leaked memory from the previous session.

- [Ref. #PEG-11448] Pathfinding limitation while using custom levels when sources/destinations are only connected to a redundant switch: Custom levels are not supported if routing dual sources (AB) to single destinations (B) connected to the redundant switch only, and vice-versa.
- [Ref. #PEG-11491] **A few built-in behavior buttons cannot use different colors:** The are some buttons that cannot use different colors: **Default Destination**, **Destination Status**, **Panel Lock**, and **Panel Home** buttons that are affected by this limitation.

If the color is changed before activating the topology, the button is set with the desired color, but once the topology is activated and the NV panel is connected, the colors cannot be changed for these above buttons.

- [Ref. #PEG-11505] **GV Convergent system incompatibility with Havant Core v16.1 b118 (GA release):** GV control systems are not currently compatible with Havant Core v16.1 b118 (GA release).
- [Ref. #PEG-11586] Logical Device Table streams sometimes will not be properly displayed: It has been found that, in some rare circumstances, opening the Logical Device Table would not show available streams in the Stream Browser section. Using the refresh button once the stage task is open corrects the issue.
- [Ref. #PEG-11589] Sources and Destinations sometimes remain in Router Control stage after being deleted: It has been found that when deleting logical devices, either from the topology or the logical device table, that the corresponding source or destination buttons from the Router Control stage task would not dynamically disappear. Under these circumstances, they only disappear after a GV Convergent restart.

• [Ref. #PEG-11598] **Tally on V and ANC levels on NVISION panel will temporarily disappear while doing Level Map:** It has been found that while doing a Level Map action from an NVISION panel, the tally of the source on the V and ANC levels would disappear after 5-10 seconds after pressing the Level Map button to enter source audio level selection mode.

Once the source audio level is selected, the tally on the V and ANC level properly reappears.

• [Ref. #PEG-11657] **DCNM host policies may not be deleted if dynamically decreasing spigot streams/flows:** A known issue may happen in GV control systems if spigot streams/flows are decreasing which could be the case if the spigot went from a configuration with a higher number of audio streams/flows to a configuration with fewer audio streams/flows.

*Workaround:* Disable/enable DCNM control port or deactivate/reactivate the topology. This issue will be fixed in an upcoming release.

★ [Ref. #UCCM-3462] Wrong buttons are shown to a panel user navigating to a sublayout when changing a panel's root layout through the property editor: When changing the assigned layout of a panel through topology configurator, it has been observed that sometimes there are artifact buttons displayed on the modified panel when showing a different layout.

To avoid this from happening, it is recommend to navigate the panel back to the home page before changing its assigned layout.

*Workaround:* If the assignment is changed, resetting the panel by power cycling it or disconnecting and reconnecting on a soft panel will correct the issue.

## **Network Requirements**

Users can access the GV Convergent Controller from a client PC using a standard Web browser (Google Chrome). When a client logs in and launches an GV Convergent module, the software is automatically downloaded from the Controller. Consequently, no other application software is needed. This greatly simplifies installation and system maintenance.

It is recommended that the GV Convergent Controller (as well as the associated equipment it controls) be installed on a dedicated LAN, using the existing security infrastructure. A qualified system administrator should verify that the setup follows the security standards of your organization. Refer to the *GV Convergent User Guide* for software installation information.
